Hugh Grefe retired in 2015 as the Senior Executive Director for the Toledo and Northwest Ohio operations of the Local Initiatives Support Corporation. Joining the LISC staff in the fall of 1994, Grefe had served the on the program's Local Advisory Committee for several years and has supported LISC involvement in Toledo since 1988. LISC is the nation's largest community development support corporation.

During his tenure at Toledo LISC, LISC dramatically increased its investment to encourage a greater scale and sustainability of community development vision and impact in Toledo neighborhoods. Grefe oversaw the commitment of over \$106 million from LISC in Toledo's most distressed neighborhoods to help produce almost 1600 homes and 1,000,000 square feet of commercial space. Grefe graduated from Wittenberg University and earned a Master of Arts degree in American Urban History from the University of Toledo. Grefe's Master of Arts Thesis examined the urban promotion thoughts and efforts of a publisher/editor of the Toledo Blade and his contemporaries in nineteenth-century Toledo.
