937.01. Meters to be furnished by the City.

All water meters of sizes five-eighths inch, three-fourths inch, one inch and one and one-half inch except meters for air conditioning, lawn sprinkling, emergency supply, re- registering or auxiliary meters and meters for fire service connections, or for vessels moored during the winter season, shall be furnished by the Division of Water at its own expense.

937.02. Meters to be furnished by individuals.

All meters of a size larger than provided in Section937.01, re-registering or auxiliary, meters for air conditioning, lawn sprinkling, and fire service connections, and for vessels moored during the winter season, shall be furnished and shall comply with the specifications prescribed by the Commissioner of the Division of Water, and shall be of the make, type, model and design approved and adopted for use by such Commissioner, which water meters shall be set by the employees of the Division of Water only, at the expense of the person applying therefor. No make, model or design other than that approved, adopted and meeting the requirements or specifications of such Water Commissioner, shall be set or used for water measurement.

937.03. Assignment of privately owned meters to City.

The Director of Public Utilities is hereby authorized to enter into agreement with individual meter owners, providing for the taking of title to meters referred to in Section 937.01 by the Division of Water of the City, the Division of Water in consideration thereof, agreeing to keep and maintain such meters so transferred in repair at the expense of the Division of Water of the City. Nothing in this chapter shall be construed as compulsory in relation to water consumers turning over their meters to the City.

937.04. Restrictions on assignment of meters.

The assignment of water meters to the Division of Water under the provisions of Section937.03 shall be subject to the following restrictions: If a meter is assigned to the Division of Water all bills of any nature rendered prior to May 5, 1941, shall be paid in full. Assignment of meters with repair bills dated after May 5, 1941, must be made within twenty days of the date of such repair bill, in which case such repair bill will be cancelled, providing that all other bills are paid in full.

937.05. Further purchases of used meters prohibited.

Except for the consideration stated in Section937.02, purchases of used water meters by the Division of Water are hereby terminated.

937.06. Customers responsible for meters and remote registers.

(a) In all cases where the Department of Public Utilities has furnished a water meter and/or remote register, at its expense, or has acquired title to any water meter as hereinbefore provided, the customer will be charged and held responsible for all damages, repairs or costs of replacement occasioned by frost, hot water, or neglect on the part of such customer, as determined by the Department of Public Utilities.

(b) Customers shall be held responsible for, and shall reimburse the Department of Public Utilities for the loss or theft of any meter and/or remote register provided by the Department of Public Utilities.
