## STAFF ANALYSIS

The request is for a revocation of a Special Use Permit (SUP) for a convenience store at 525 Dorr Street, approved by Toledo City Council on November 13, 2007 via Ord. 724-07. The Special Use Permit is being reviewed because the site is not in compliance with the regulations of the Toledo Municipal Code.

The request was for a Special Use Permit for a convenience store located in the tenant space of a shopping center. The Special Use Permit did not include building elevations or landscaping; submittal of this material was not required for Special Use Permits in tenant spaces at the time.

The site is not in compliance with the Toledo Municipal Code as the site causes negative secondary effects for the surrounding neighborhood. Per TMC§1104.0600 – *Convenience Stores*, Special Use Permits for a convenience store are subject to review on an annual basis and may be amended or revoked by action of City Council in consultation with the Plan Commission if said convenience store is determined to have significant negative secondary effects that have not been sufficiently alleviated under zoning, building or health code regulations. The Toledo Municipal Code defines negative second effects as:

- A. Litter, broken bottles and paper discards that diminish the aesthetics of the immediate area
- B. Noise, disruption from the carryout to the quiet enjoyment of adjoining residential districts, and public and civic uses.
- C. Traffic, traffic noise and congestion.
- D. Pedestrian congestion which can intimidate individual patrons and disrupt neighborhood civility.



**STAFF ANALYSIS (cont'd)**

Since November 13, 2007 (the date when Ord. 724-07 was approved), the site has had three hundred and twenty-three (323) criminal reports filed with Toledo City Police. Recently, this includes twenty-four (24) reports in 2021, thirty-seven (37) reports in 2020, and twenty-one (21) reports in 2019. Police reports vary greatly, with the top five (5) offenses being Warrant Service, Simple Assault, Disorderly Conduct While Intoxicated, Criminal Trespassing, and Forgery. In 2019, 2020, and 2021 there were a total of two-hundred fourteen (214) calls to 911. Two (2) violations have been issued by Code Enforcement since 2015.

Additionally, the neighborhood organization, Junction Coalition, has voiced concerns about the convenience store to City Council.

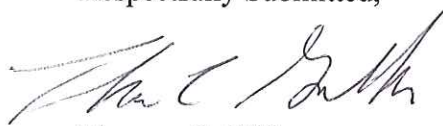
The site does not meet the stated purpose of the Toledo Zoning Code, which is to protect the health, safety, and general welfare of the citizens of Toledo, as is evident from the reported criminal issues.

**PLAN COMMISSION RECOMMENDATION**

The Toledo City Plan Commission recommends revocation of SUP-3012-16 (Ord. 724-07) for convenience store at 525 Dorr Street to the Toledo City Council, for the following two (2) reasons:

1. The use as it is operated does not meet the stated purpose of the Zoning Code ((TMC§1111.0706(A)); and,
2. The site does not comply with all applicable provisions of the Zoning Code (TMC§1111.0706(B))

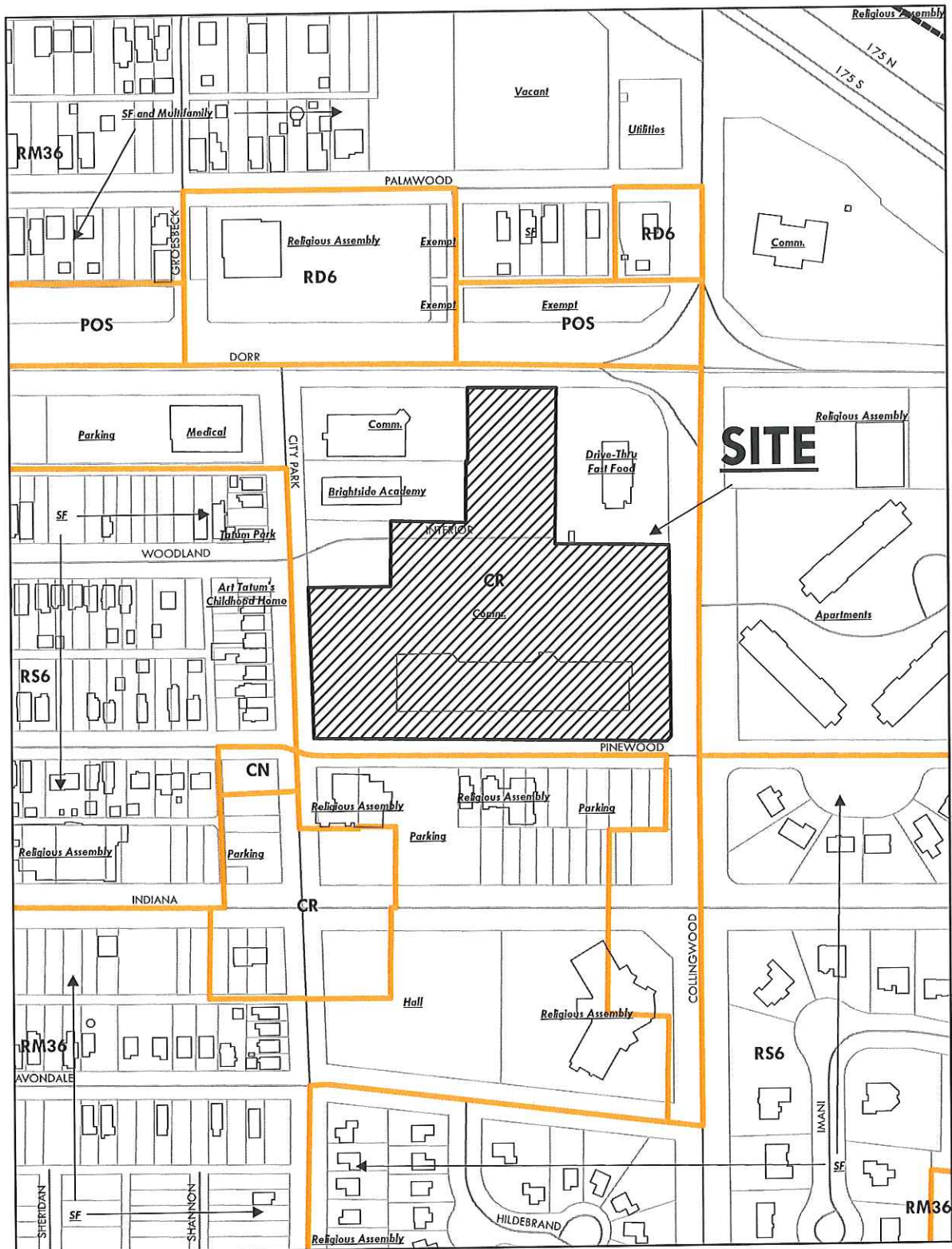
