


## GENERAL NOTES

- NO BUILDING OR OTHER TEMPORARY OF PERMANENT OBSTRUCTION BE PLACED UNDER AERIAL EQUIPMENT OR OVERHEAD WIRES, EASY ACCESS TO ALL COMPANY FACILITIES AND EQUIPMENT IS MAINTAINED AT ALL TIMES.
- 2.) ALL MATERIAL AND CONSTRUCTION SHALL CONFORM TO THE CURRENT MATERIAL AND CONSTRUCTION STANDARDS AND SPECIFICATIONS OF THE CITY OF TOLEDO, OHIO AND/OR STATE OF OHIO, DEPARTMENT OF TRANSPORTATION, CONSTRUCTION AND MATERIAL SPECIFICATIONS.
- 3.) THE WORK SHALL BE PERFORMED BY A COMPETENT CONTRACTOR ACCEPTABLE TO THE DIVISION OF ENGINEERING SERVICES, THE PERFORMANCE OF WORK BY OTHER THAN LICENSED CONTRACTORS MAY BE PERMITTED ONLY UPON WRITTEN APPROVAL BY THE COMMISSIONER OF THE DIVISION OF ENGINEERING SERVICES.
- 4.) NECESSARY PERMITS SHALL BE OBTAINED BEFORE THE COMMENCEMENT OF ANY CONSTRUCTION WORK. THE CONTRACTOR SHALL NOTIFY CONSTRUCTION ENGINEER AT LEAST THREE (3) DAYS PRIOR TO THE START OF CONSTRUCTION TO MAKE ARRANGEMENTS FOR INSPECTION OF THIS WORK.
- 5.) ALL DISTURBED AREAS SHALL BE PROVIDED WITH 653 2" TOPSOIL AND ITEM 659 – SEEDING AND MULCHING INCLUDING COMMERCIAL FERTILIZER, COST OF THIS WORK SHALL BE INCLUDED IN THE APPROPRIATE ITEMS.
