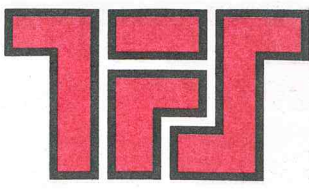
The only funding is for the fence rebuilding and would be used for this. The park is already mowed by the City of Toledo.

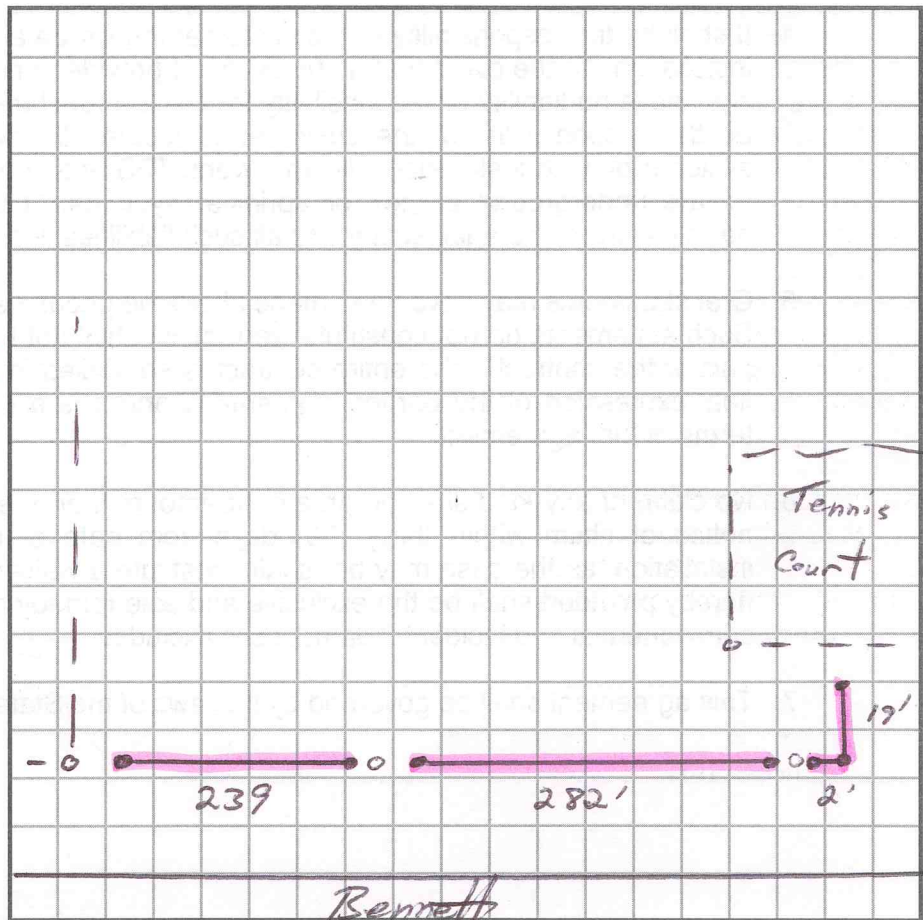
