STAFF ANALYSIS

The request is a revocation of a Special Use Permit (SUP) for a gas station at 1201 (1203) Dorr Street approved by Toledo City Council on February 2, 2021 via Ord. 33-21. The Special Use Permit is being reviewed because the site is not in compliance with the regulations of the Toledo Municipal Code or the conditions of approval of Ord. 33-21.

STAFF ANALYSIS (cont'd)

The request was for a SUP amendment to facilitate the development of a forty-eight (48) square foot expansion of a gas station and convenience store at 1201 (1203) Dorr Street. The ±0.37 acre site is Zoned CR-Regional Commercial, and received an initial SUP in 1980 via Ord. 505-80 for the use. Since the initial SUP was approved, two (2) amendments were approved to add a walk-in cooler (SUP-26-87) and to construct an addition (SUP-11002-19). The latter was filed after receiving a Stop Work Order from the Division of Building Inspection for beginning construction without appropriate permitting.

The site is not in compliance with the Toledo Municipal Code as the site causes negative secondary effects for the surrounding neighborhood. Listed as a condition of approval in Ord. 33-21 is the following:

- The Special Use Permit may be reviewed for compliance with the conditions of approval, negative secondary effects, and adherence to all requirements of the Toledo Municipal Zoning Code. If outstanding issues are found and not addressed the Special Use Permit may be considered for revocation.

Negative secondary effects are described in *TMC§1104.0600 – Convenience Stores*. The SUP granted be amended or revoked by action of City Council in consultation with the Plan Commission if the convenience store is determined to have significant negative secondary effects that have not been sufficiently alleviated. Negative secondary effects are defined as:

- A. Litter, broken bottles and paper discards that diminish the aesthetics of the immediate area.
- B. Noise, disruption from the carryout to the quiet enjoyment of adjoining residential districts, and public and civic uses.
- C. Traffic, traffic noise and congestion.
- D. Pedestrian congestion which can intimidate individual patrons and disrupt neighborhood civility.

Since February 2, 2021 (the date when Ord. 33-21 was approved), the site has had three (3) complaints filed with the Division of Code Enforcement, forty-one (41) criminal reports filed with Toledo City Police, and twenty-seven (27) complaints made to Toledo City Council. Code Enforcement issues include not having the dumpster fenced and the need for repairs to the building and to the fencing on site. Police reports vary greatly, with the top five (5) offenses being warrant service, criminal trespassing, disorderly conduct, obstructing official business, and aggravated menacing. The nature of the City Council complaints includes unwanted entry, harassment, and disorderly conduct.

STAFF ANALYSIS (cont'd)

The site does not meet the stated purpose of the Toledo Zoning Code, which is to protect the health, safety, and general welfare of the citizens of Toledo, as is evident from the reported nuisance, criminal, and Code Enforcement issues. Additionally, the site is not in compliance with Ord. 33-21 for a Special Use Permit.

PLAN COMMISSION RECOMMENDATION

The Toledo City Plan Commission recommends revocation of SUP-11002-19 (Ord. 33-21) for a gas station at 1201 (1203) Dorr Street to the Toledo City Council, for the following two (2) reasons:

1. The use as it is operated does not meet the stated purpose of the Zoning Code ((TMC§1111.0706(A)); and,
2. The site does not comply with all applicable provisions of the Zoning Code (TMC§1111.0706(B))

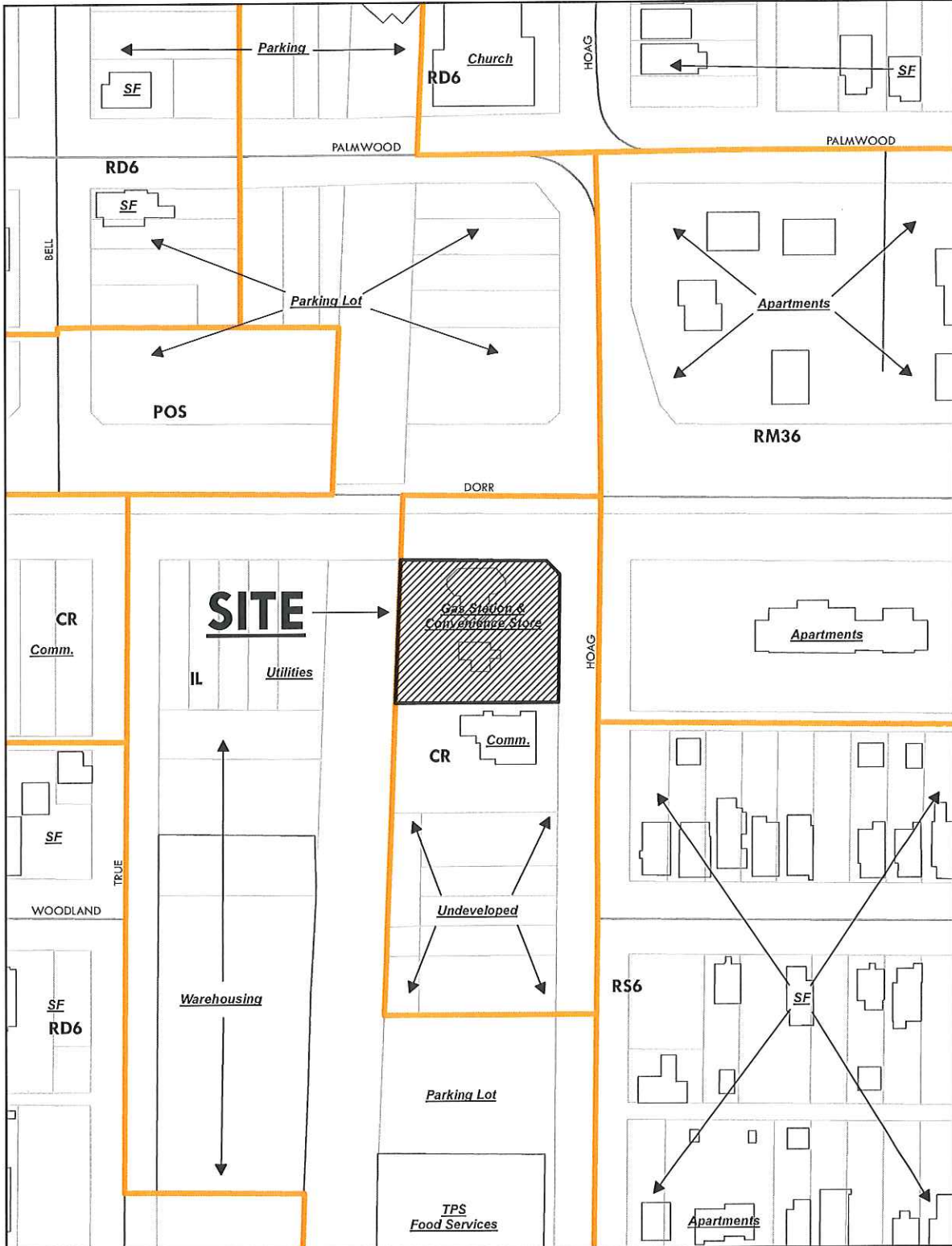

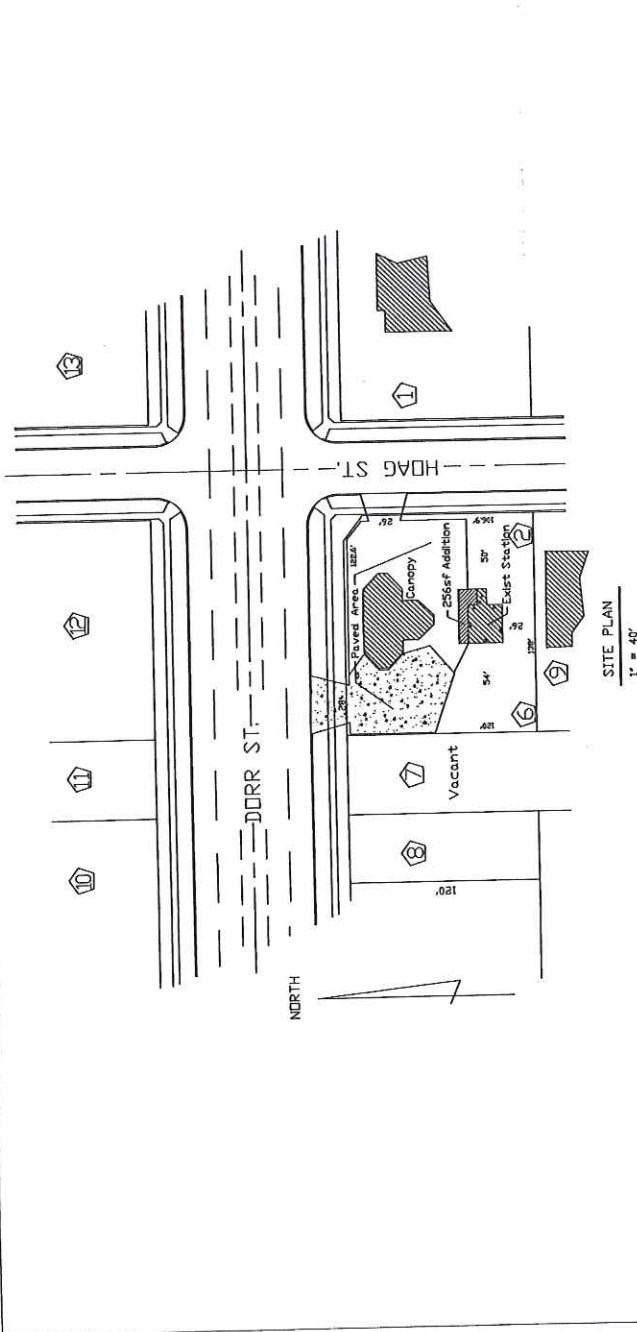
