## **STAFF ANALYSIS**

The applicant is requesting a zone change from IL (Limited Industrial) to CD (Downtown Commercial) for a site located at 12 N St. Clair Street. The property is located in the Warehouse District along a dense commercial corridor, surrounded by other urban commercial buildings from the late 1800s and early 1900s. The applicant, Neighborhood Health Association of Northwestern Ohio, owns the building and intends to use the building as medical offices. The current industrial zoning does not permit this use. The proposed zoning of Downtown Commercial will permit the proposed use, naturally suit the urban commercial/mixed-use building, and fit in with zoning of surrounding properties.

### Applicable Plans

The Toledo 20/20 Comprehensive Plan targets this site for “Downtown Commercial” land uses in the Future Land Use map for Downtown. The Downtown Toledo Master Plan calls for the Identification of Strategic Redevelopment and Infill Sites within the Priority Action Items, and the rezoning of this property will allow it to be redeveloped. Finally, the Warehouse District Plan (2017) calls for this property to be used for commercial purposes within the Proposed Land Use map. The proposed zone change is in line with these recommendations.

## **STAFF RECOMMENDATION**

The staff recommends that the Toledo City Plan Commission recommend approval of Z-2009-22, a request for a Zone Change from IL (Limited Industrial) to CD (Downtown Commercial) at 12 N St. Clair St, to the Toledo City Council for the following reasons:

1. The request conforms with existing land uses within the general vicinity of the subject property (TMC§1111.0606.C)
2. The request conforms with the Toledo 20/20 Comprehensive Plan, applicable neighborhood plans, and the stated purpose of the Zoning Code (TMC§1111.0606.A)

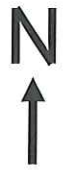

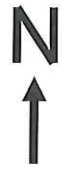
