(C) A substantially final form of the Special Assessment Agreement, by and between the County Treasurer of Lucas County, Ohio, the City, the Northwest Ohio Advanced Energy Improvement District (the “District”), the Owner, and Greenworks Lending LLC (the “Investor”); and

(D) A substantially final form of the Energy Project Cooperative Agreement, by and between the City, the District, the Owner, and the Investor.

4. With respect to the proceedings pertaining to the adoption of Ordinance O-___-20:

(A) All meetings of the City Council, and of its committees and any other public bodies, at which the formal actions were taken, or at which deliberations that resulted in such formal actions were held, were open meetings, and such formal actions were taken and any such deliberations took place while such meetings were open to the public, in compliance with all legal requirements, including Ohio Revised Code Section 121.22.
