### Project Plan for 2634 Robinwood Avenue, Toledo, Ohio 43610

The real property owned by Eric Pilcher, at 2634 Robinwood Avenue, Toledo, Ohio 43610, serves as a personal residence. The legal description of the property is set forth on the attached Exhibit A. The property will be subject to special assessments for energy improvements in accordance with Revised Code Chapter 1710.

The energy efficiency savings for the project are expected to be 15% or more annually and consist of the following energy efficiency elements:

1. Boiler Replacement
2. Insulation & Sealing

Total project cost: \$10,129.30

Total cost including financing and other charges: \$10,588.12
