Where, in 2016 Bocky Ridge Development LLC applied for a permit to dump the spent lime sludge directly into a quarry pit in Benton Township. Thereafter, the BENTON TOWNSHIP QUARRY DUMPING OPPOSITION was formed and began organizing efforts to obtain more information and to inform more people in the area. In March 2019, Ottawa County Common Pleas Court granted a summary judgment in favor of Benton Township making the temporary injunction permanent.

Where, in December 2020, the Ohio Supreme Court refused to hear the appeal made by Rocky Ridge Development upholding the permanent injunction.
