To whom this may concern,

I am applying for a height variance for the fence encompassing my backyard, for various reasons.

I had contracted with a fence company to install a 5 ft fence to enclose my backyard. I have a inground pool and dogs. I am 77 feet from the edge of the sidewalk to the edge of my fence off Glendale Ave. The fence company was to pull the permits and erect the fence. I have only lived here for a short time, and I am not familiar with the process or requirements for a permit when it comes to a fence, as I had moved here from another state and location that did not require permits. This fence replaced an existing 6 ft privacy fence that was already on this property when I purchased my home. After the job was finished to my surprise, I received a letter from the city stating my fence was not permitted. I spoke with the inspector and sent him a copy of the text between myself and the fence company, where I had specifically asked them if they had secured the permits for the fence before they had started to erect the new fence. To which they replied yes they had pulled the permits. The city inspector informed me that I could file this appeal during one of our conversations. He said to file for the height variance mostly because I do have dogs and a pool. The fence doesn't obstruct any line of sight because it is what they refer to as a Kentucky Rail Fence, you can see through it. The inspector had informed me that the reason for the height variance was because as things stand now the fence is not to exceed 42 inches. This creates a huge problem; 42 inches is the height of a hurdle, for track. If people can jump over it, my dogs will definitely clear it. I have 4 Siberian Huskies and Siberian Huskies are known for being escape artists. They need no help in this department, and I would prefer that my dogs don't have the opportunity to run out into traffic on Glendale Ave. They can be hit by a car, cause a serious accident, and people can get hurt or worse.

I also don't feel that a 42-inch fence is going to serve as a deterrent for people getting into my backyard. There are many children in this neighborhood that could easily get over a 3 ½ foot fence and access the pool. I believe that the 5 ft fence already in place would pose more of a problem in work and time to overcome. I will say that since its erection I haven't had any issues. This is an older neighborhood and my neighbors have been very happy with the improvements I have already made. With the new fence drug dealing has stopped

because they can't hide behind it and no more stolen motorcycles can be hidden behind it. I have suffered some retaliation.

I did contact an Attorney concerning the fence company and he informed me that it would cost me more to pursue them than I would recover.

I have also contacted many fence companies and the overwhelming response i have received is that they don't want to TOUCH IT because they didnt put it up. They will however build me a new fence starting at \$5,000, and the existing fence removed for an additional fee.

I asked that you please grant me the height variance so the fence can stay at the current 5 foot height. It is not an obstruction, it's not ugly, it keeps my dogs in, and people out. I am only one person with very limited resources and I really cannot afford to do anything else.

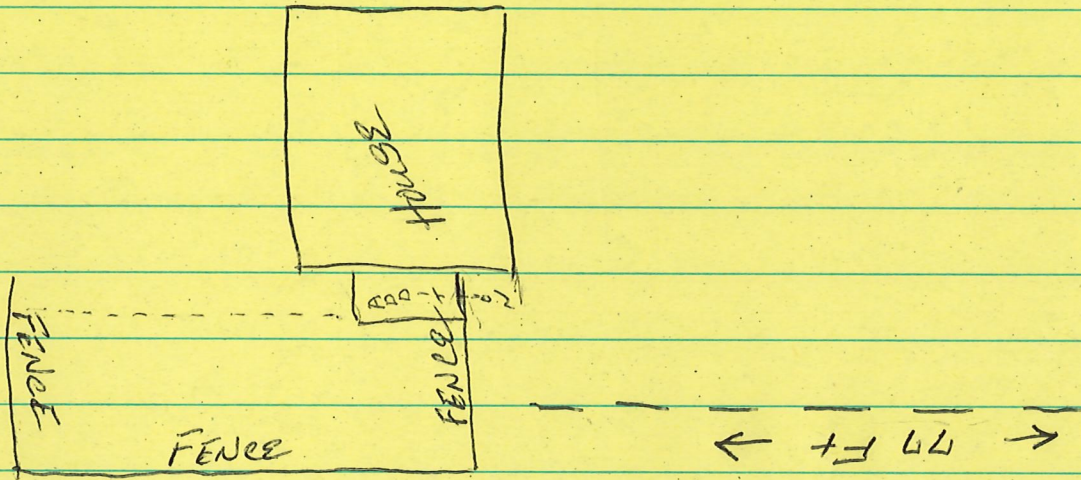
