thence South 69' 47' 20' West, along the North line of the South 1/2 of the Southeast X of said Section 11, a distance of 336.17 feet to a X inch diameter by Iron rod found at the Northerly extension of the East line of Late 2

thence South 00° 23' 45" West, along the Northerly extension of the East

at the Northwest corner of Lot 2 in sold Capital Commons Center Plat One; thence North 89' 41' 00" West, along the North line of sold Capital Commons Center Plat One, a distance of 699.98 feet to the POINT OF BEGINNING.
