## STAFF ANALYSIS

The applicant is requesting a Special Use Permit for a Day Care Center at 5045 W. Sylvania Avenue. The ± 3.07 acre site is zoned RS12 and contains a 9,462 sq. ft. commercial building that was previously used as a community center. Adjacent land uses include single dwelling residential to the north, a church and single dwelling residential to the east, single dwelling residential to the south, and a greenhouse, funeral home, and Wildwood Metropark to the west.

An overview of project details is included in this analysis. A detailed list of all project related items is included in the agency conditions at the end of this report.

### Use Specific Regulations

- a. A Day Care Center must have building frontage on a major street. The site is compliant with this regulation. Sylvania Avenue is classified as a major street.

### Parking

- a. A portion of the parking area will be removed and reconfigured to accommodate the outdoor play area.
- b. The use requires 24 parking spaces and 51 are provided. The site exceeds the 150% allowable maximum for parking spaces at 220%. However, the site is existing and is reducing the total number of spaces bringing the site closer into compliance.

### Landscaping

- a. The reuse of an existing site is not required to comply fully with current landscape standards, but must bring the site closer to compliance.
- b. Staff is requesting a 7' Type B landscape buffer be installed along the 225' perimeter of the outdoor play area in place of the proposed planters with the pavement removed.

### Elevations

- a. There are no changes proposed for the exterior of the building.

### 20/20 Plan

The Toledo 20/20 Comprehensive Plan recommends this site for Single Family Residential uses. This category accommodates the development of single family units along with supportive uses such as libraries, schools, and churches. The day care center is compatible with this designation.

## PLAN COMMISSION RECOMMENDATION

The Toledo City Plan Commission recommends approval of SUP-3001-22, a request for a Special Use Permit for a Day Care Center located at 5045 W. Sylvania Avenue, to the Toledo City Council, for the following **two (2) reasons**:

1. The use complies with all applicable provisions of the Zoning Code **TMC 1111.0706.B; and**
2. The use is compatible with adjacent uses in terms of operating characteristics (such as noise, traffic generation, and other impacts associated with the use's operation) **TMC 1111.0706.C.**

The Toledo City Plan Commission recommends approval of SUP-3001-22, a request for a Special Use Permit for a Day Care Center located at 5045 W. Sylvania Avenue, subject to the following **thirteen (13)** conditions:

The following conditions are listed by agency of origin. Applicants are encouraged to contact each of the agencies to address compliance with their conditions.

### Engineering Services

1. All **proposed** sidewalk, drive approaches, curb, and pedestrian curb ramps within the public right-of-way shall be constructed in accordance with the City of Toledo Construction Standards, Specifications, Toledo Municipal Code, and Americans with Disabilities Act guidelines.
2. All commercial drive approaches, (along with the sidewalk through the drive) shall be constructed with 8" thick concrete per City of Toledo Construction Standards and Specifications. No curb shall be permitted in the right-of-way along either side of a drive approach. **No horizontal curb cutting will be permitted to create a curb drop/opening.** Existing drive approaches, including the curb drop, that will no longer be utilized shall be removed and restored with curb to match the adjacent curb.

### Fire Department

3. It appears that this building will undergo a change of use. This will require compliance with all applicable Fire Sprinkler and Alarm, Building, Electrical, Mechanical and Plumbing code requirements.
4. Approved Premises identification is required.

**STAFF RECOMMENDATION (cont'd)**

Sewer and Drainage Services

5. S&DS requires that all private sewer lines that are not being removed or properly abandoned (both storm & sanitary) be cleaned and inspected.
6. S&DS requires that the private sanitary lines (after they have been cleaned) that are not being removed or properly abandoned be televised from the building (or private cleanout) to where they connect to the public sewer system if this has not been done in the past (2) two years. An electronic (DVD/memory stick) shall be provided to S&DS demonstrating the lines cleaning and integrity.

7. A 7' Type B landscape buffer shall be provided along the perimeter of the outdoor play area. The 225' area requires 9 trees and 34 shrubs. A privacy fence may substitute for the shrub requirement. **Shall be indicated on a revised site/landscape plan.**
8. Dumpsters shall be screened from view and may not be located in any required setback or landscape buffers and as far from residential areas as possible. Fencing details shall be provided. **TMC 1108.0203.G. Shall be indicated on a revised site/landscape plan.**
9. Planting details shall be provided such as the type, size, and quantity of plantings. **Shall be indicated on a revised site/landscape plan.**
10. **Landscape areas shall be indefinitely maintained.** Landscaped areas may not contain bare soil, aggregated stone or decorative rock. Any ground area must be covered with hardwood mulch, grass or other vegetative ground coverage.
11. The Special Use Permit may be reviewed for compliance with the conditions of approval, negative secondary effects, and adherence to all requirements of the Toledo Municipal Zoning Code. If outstanding issues are found and not addressed the Special Use Permit may be considered for revocation.
12. Minor adjustments to the site plan that do not violate the above conditions, or the Toledo Municipal Code, may be reviewed and approved by the Director of the Toledo City Plan Commission. Major adjustments will require an amendment to the Special Use Permit.
13. No permits shall be issued until arrangements satisfactory to the Director of the Toledo City Plan Commission have been made for compliance with the conditions as set forth above.

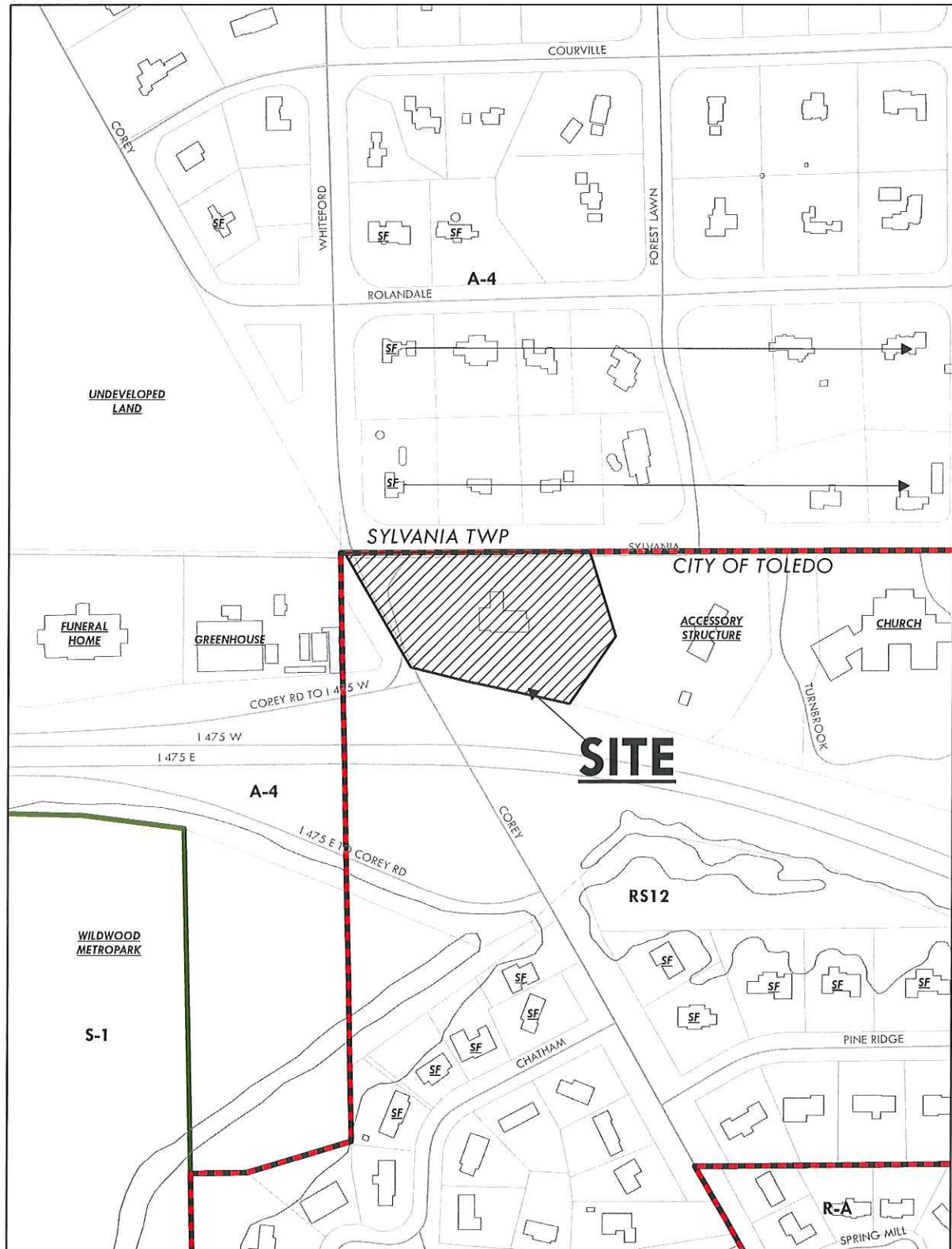

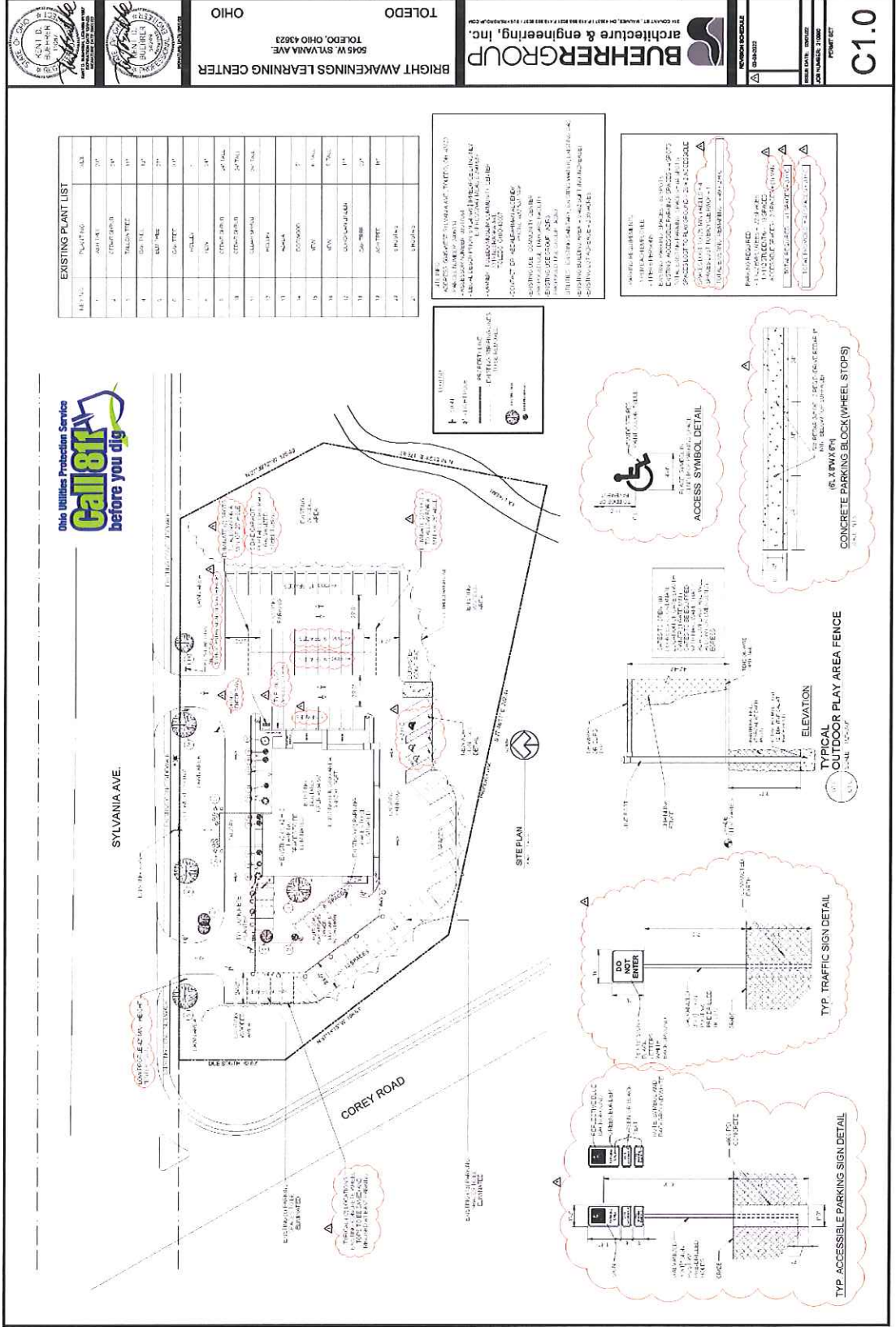

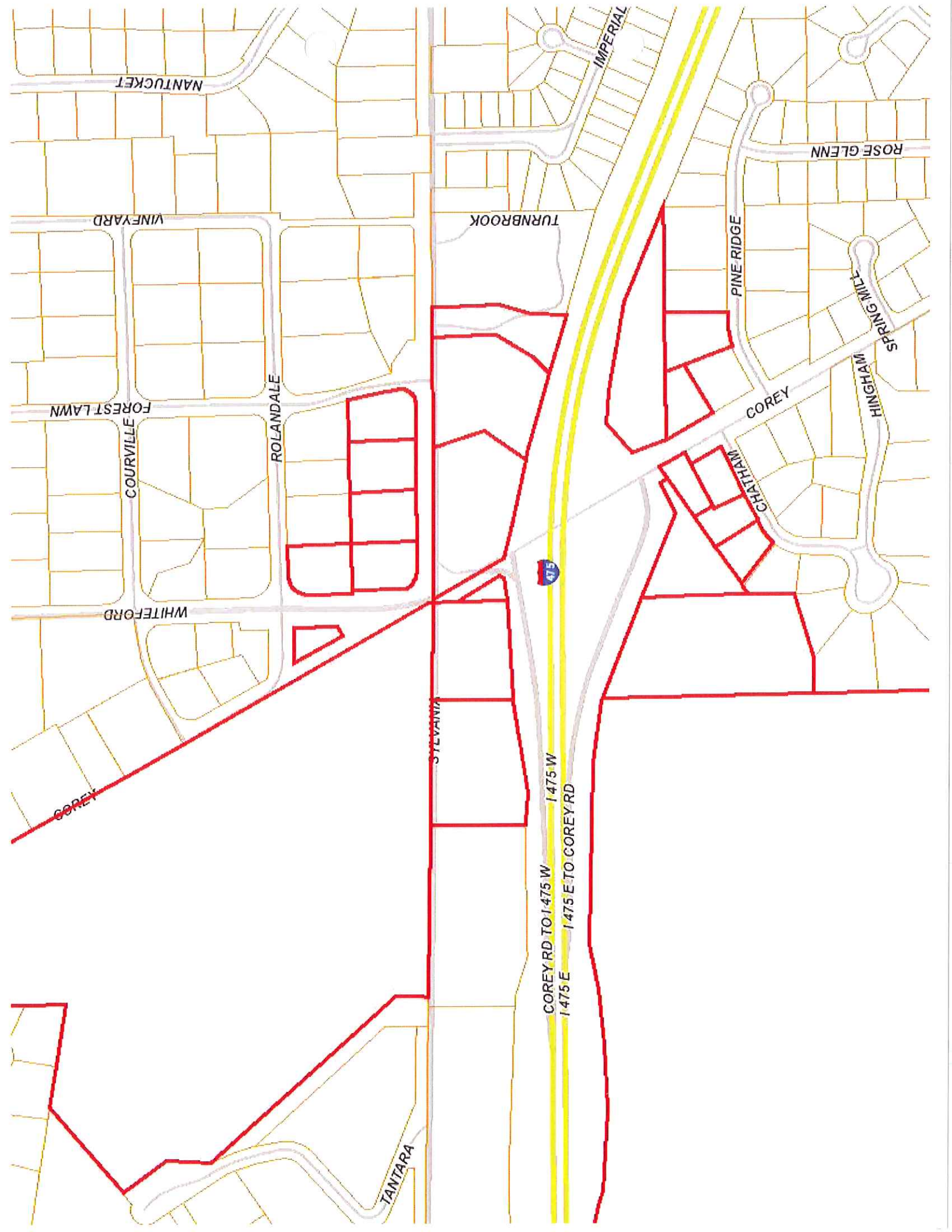
