STAFF ANALYSIS

The Waterville Township Zoning Commission requests an amendment to the Waterville Township Zoning Resolution to modify Table 3-1 by adding Data Processing Centers as a Conditional Use in the "A" Agricultural District and to add a definition to Section 20.3 for defining a Data Processing Center. The proposed amendment is to allow for a specific use, data centers, allowed in the "A" Agricultural District zoning classification with an approved Conditional Use permit. A data center is a facility housing computer equipment for storing and processing data.

Staff will work with the township zoning commission to create design guidelines that include landscaping, fencing, and setbacks when abutting residential districts for the data center conditional use site plan. This amendment is similar to Monclova Townships. The township's amendment is shown is shown in EXHIBIT "A."

STAFF RECOMMENDATION

The staff recommends that the Lucas County Planning Commission recommend approval of the proposed amendment to the Waterville Township Zoning Resolution shown in EXHIBIT "A" to the Waterville Township Zoning Commission and Township Trustees.
