STAFF ANALYSIS

The applicant is requesting a Zone Change from CR Regional Commercial to RS6 Single Dwelling at 2215 Oak Grove Place (2251 Tremainsville Road rear). The site is a recently created \pm 0.17 acre lot formed from a lot split of the parcel located on the southwest corner of Tremainsville Road and Oak Grove Place. A 7,232 square foot commercial office building exists on the new parcel fronting onto Tremainsville Road. The remainder of the lot split fronts onto Oak Grove Place and consists of a single-family dwelling with detached garage. Surrounding land uses include a bar/restaurant to the south and single-family dwellings to the north, east and west. The applicant is requesting the Zone Change in order to be able to obtain residential financing on the single-family dwelling.

Toledo 20/20 Comprehensive Plan

The Toledo 20/20 Comprehensive Plan identified the future land use designation as Neighborhood Commercial. The intent of the neighborhood commercial future land use designation is to encourage predominantly small and medium scale commercial uses to serve the nearby neighborhoods.

Staff recommends approval of the zone change because it is compatible with zoning and land uses in the immediate area. Additionally, RS6 zoning is established to the northwest of the subject site. Finally, the proposed zone change corrects an issue of a non-conforming land use in the proper zoning classification.

STAFF RECOMMENDATION

The Toledo City Plan Commission recommends approval of Z-12002-18, a request for Zone Change from CR Regional Commercial to RS6 Single Dwelling at 2215 Oak Grove Place (2251 Tremainsville Road rear), to Toledo City Council for the following three (3) reasons:


