SECOND READING ITEMS:

[O-183-24](#) Approving the Lucas County Solid Waste Management District's Amended Draft Solid Waste Management Plan Pursuant to Ohio Revised Code Section 3734.50.

Body: SUMMARY & BACKGROUND:
The Lucas County Solid Waste Management District (the "District") is established by Lucas County pursuant to Chapter 343 of the Ohio Revised Code ("ORC") to effectuate the purposes of preparing,

amending, adopting, submitting, and implementing a Solid Waste Management Plan (the “Plan”) pursuant to Sections 3734.52, et seq., of the ORC for the safe and sanitary management of solid wastes within the territory of the District. The Plan is prepared in accordance with ORC Section 3734, the State of Ohio’s Solid Waste Management Plan and the Ohio Environmental Protection Agency’s (“OEPA”) guidelines. The Plan also describes strategies and programs that will be implemented to meet or exceed the minimum state waste reduction goals and objectives.

The District completed the draft amended Plan and submitted it to the OEPA for review and comment on May 1, 2023 and the OEPA provided comments in a non-binding advisory opinion on June 15, 2023. The District’s Policy Committee has reviewed the non-binding advisory opinion received from the OEPA and taken these comments into consideration and incorporated changes into the amended Plan as appropriate.

The District has conducted a 30-day comment period from February 4, 2024 to March 5, 2024 and a public hearing was held on March 5, 2024 to provide the public an opportunity to comment on the Plan. The Policy Committee adopted the amended plan on March 13, 2024 and a copy of the plan was delivered to the required legislative authority. The amended Plan identifies the District’s strategy for the management of solid wastes generated in Lucas County through the year 2039. ORC 3734.55(B) requires the legislative authority of a municipality to approve or disapprove the District’s amendments to the Plan.

 Toledo Municipal Code Chapter 167 governs the creation,

membership, and duties of the Arts Commission. This Ordinance repeals or replaces relevant sections of that chapter pertaining to meeting requirements of the Arts Commission, when the terms begin and end, acceptance of donations, and updates and clarifies the one percent for the arts calculation.

An application (Z-101006-23) for a proposed change in zoning for the property located at 1501 Monroe Street, Toledo, Ohio, was submitted to the Toledo City Plan Commission for its review and recommendation.

On March 14, 2024, the Toledo City Plan Commission recommended approval of the request for a zone change from CR (Regional Commercial) to CM (Mixed Commercial-Residential) for the property located at 1501 Monroe Street, Toledo, Ohio.

Authorizing the expenditure of \$12,500 from the Capital Improvement Fund District Improvement Program for the Goddard Field improvement project; authorizing the Mayor to enter into an amended contract for said purpose; and declaring an emergency.

Body: SUMMARY & BACKGROUND:

The Old Orchard Neighborhood Association submitted a District Improvement Program (DIP) application to provide funding to install decorative columns and landscaping at Goddard Field. The District Improvement Review Committee convened on September 5, 2023, and recommended approval of this application in an amount of \$134,624.99. Ordinance 462-23 authorized the expenditure of DIP funds for this project.

Goddard Field serves as an important entry point to the Old Orchard neighborhood. This installation serves to enhance the identity of this proud Toledo community. The DIP allocation will fund the entire cost of the project.

During the installation of landscape material associated with this project, it was determined the soil present in the flower beds was of such poor quality that it would not support healthy plant material. Fresh topsoil will be brought into the site to ensure the landscape beds can be maintained in a healthy condition. Furthermore, the neighborhood requested that 2 more flower beds be added to the scope of work to further enhance the project. This Ordinance authorizes the expenditure of an additional \$12,500 to pay for the additional costs of the topsoil and flowerbed components of the project.

Approving a Petition For Special Assessments for Special Energy Improvement Projects and a Project Plan for the Northwest Ohio Advanced Energy Improvement District under Chapter 1710 of the Ohio Revised Code for The Maritime Academy of Toledo, Inc. and 214 Walnut Street, Toledo, Ohio 43604; to authorize and levy special assessments for the purpose of acquiring, constructing, and improving certain public improvements in the City of Toledo in cooperation with the Northwest Ohio Advanced Energy Improvement District; and declaring an emergency.

Body: SUMMARY & BACKGROUND:

The City of Toledo, the City of Oregon, the City of Maumee, the City of Northwood, the City of Perrysburg, the City of Sylvania, the Village of Whitehouse, the Township of Monclova, the Township of Springfield, the Township of Swanton, the Township of Sylvania, the Township of Washington, the City of Napoleon, and the Toledo-Lucas County Port Authority have partnered to create an Energy Special Improvement District (“District”) under Ohio Revised Code Chapter 1710 and a non-profit corporation, known as the Northwest Ohio Advanced Energy Improvement District (“Corporation”), to govern the District. Property owners within the District are permitted to make certain “energy efficiency improvements” to their properties, which constitute a “special energy improvement project”, and pay for the cost of the special energy improvement project by way of special assessments in accordance with the process set out in Chapters 727 and 1710 of the Ohio Revised Code. Revised Code Section 1710.01(G) provides that special energy improvement projects (including energy efficiency improvements) constitute public improvements and are therefore subject to special assessments.

The Maritime Academy of Toledo, Inc. (the “Petitioner”) is the owner of 100% of the property described on **Exhibit A** attached hereto (the “Property”). The Petitioner has caused the completion of an energy assessment of the Property.

The energy assessment has identified energy conservation measures, all of which qualify as energy efficiency improvements as defined in Revised Code Section 1710.01(K), which Petitioner has determined to proceed with implementing in conjunction with financing to be secured by and repaid through special assessments.

Petitioner has submitted to this Council the Petition for Special Assessments for Special Energy Improvement Projects (the “Petition”) seeking (i) the addition of certain of its property to the District and (ii) approval of an amendment to the District’s comprehensive plan for special energy improvement projects to include the The Maritime Academy of Toledo, Inc. Special Energy Improvement Project (the “Special Energy Improvement Project”) and requesting that the Project be undertaken by the District and that the costs thereof be specially assessed against the Property specially benefited thereby.

A complete list and description of the Special Energy Improvement Project is on file with the Clerk of Toledo City Council and is attached as Exhibit B to this Resolution. **Exhibit B** provides the following information for the Special Energy Improvement Project:

1. Identification of the parcel number and name of the Property/building to be improved;
2. A description of the nature of the Special Energy Improvement Project for the particular parcel;
3. The estimated amount of the special assessment to be levied against the Property (the “Special Assessment) and the number of years the Special Assessment will be collected

(if not paid in cash within 30 days after the passage of the assessing ordinance as provided by law).

The total dollar cost of the Special Energy Improvement Project, including accrued interest and the associated closing costs, is estimated to be Eight Hundred Thirty Thousand Six Hundred Forty and Zero Cents (\$830,640.00). Each semi-annual payment represents the payment of a portion of the principal of and interest, the program administration fee, and the Lucas County, Ohio special assessment collection fee due with respect to each semi-annual payment. The total amount to be assessed against the property pursuant to this Ordinance is One Million Two Hundred Twenty Seven Thousand Fifty Four and Fifty Cents (\$1,227,054.50).

The cost of the Project will be funded through a loan from the Toledo-Lucas County Port Authority's Northwest Ohio Bond Fund. Ultimately, the loan will be repaid over time from the Special Assessments paid by Petitioner. Petitioner, in turn, is expected to be able to pay a portion of the Special Assessment from the energy savings estimated to be achieved as a result of the Special Energy Improvement Project.

The annual Special Assessment for the Special Energy Improvement Project is to be paid in semi-annual payments over fourteen years. The plans and specifications for the Special Energy Improvement Project are on file with the Clerk of Council. The Petitioner also waives all further notices, hearings, claims for damages, rights to appeal and other rights of property owners under the law, including but not limited to those specified in the Ohio Constitution, Chapter 727 of the Revised Code, the Toledo City Charter and the Toledo Municipal Code. Petitioner consents to the immediate imposition of the Special Assessment upon the Property specially benefited by Special Energy Improvement Project.

This special assessment process is a voluntary process with one hundred percent of the cost of the Special Energy Improvement Project being assigned to the specially benefited Property. This resolution accepts and approves the petition from Petitioner, to begin that special assessment process, and is accompanied by an ordinance to proceed with Petitioner. When the Special Energy Improvement Project is complete and the final costs known, an assessing ordinance directing that the necessary Special Assessment be made against the benefited Property will be presented to the Council.

Body: SUMMARY & BACKGROUND:

A District Improvement Program application for \$20,000 has been submitted to provide funding to re-pave the parking lot at Trilby Park.

The parking lot serves the rental shelters, tennis courts, and ball diamond at Trilby Park. This re-paving project is being undertaken near the end of the useful lifecycle for the current pavement. Delaying this work would likely result in more intensive repairs at a significantly higher cost. The DIP allocation is being match by the Trilby Park Advisory to cover the \$40,000 cost of the project.

The District Improvement Review Committee convened on April 26, 2024, and recommended approval of this application in an amount of \$20,000.

Authorizing the expenditure of \$19,129 from the Water Operating Fund for emergency repair services to the natural gas pipe line that serves the Heather Downs Pump Station; authorizing the Mayor to enter into an emergency contract with GEM Inc. Rudolph Libbe Group; waiving the competitive provisions of TMC Chapter 187; and

declaring an emergency.

Body: SUMMARY & BACKGROUND:

The Heather Downs Pumping Station located at 2650 Cass Rd, Toledo Ohio boosts water pressure for South Toledo and communities to the southwest and houses other critical public utilities infrastructure. Recently the line that provides gas service to the heating system began leaking. As a safety precaution and in line with their health and safety protocols Columbia Gas Co. shut off their supply line to cut off gas flow to stop the leak and stated that it shall remain shut off until the Toledo owned section of line was repaired and passed a leak test. It was found that 110ft long 2-inch diameter natural gas service line needed to be replaced. The work has been completed in April 2024 and the gas service has been restored.

Authorizing the expenditure of \$500,000 from the Sewer Replacement Fund for the Plant Electrical Motors & Actuators Rebuild/Replacement Project at the Bay View Water Reclamation Plant; waiving the competitive bidding provisions of TMC Chapter 187 for proprietary parts and equipment replacement; authorizing the Mayor to accept bids and award contracts necessary for the Project; and declaring an emergency.

Body: SUMMARY & BACKGROUND:

The Bay View Water Reclamation Plant houses the wastewater treatment facilities which can handle up to 195 million gallons per day, and the wet weather treatment facilities which can handle up to 205 million gallons per day. The Plant as well as the outside pump stations employ numerous electrical motors, actuators and other related equipment to power and drive various equipment and treatment systems. Currently, the conditions of many electrical motors and actuators are of great concern, which upon failure could adversely affect the operational integrity of the treatment systems.

The Division of Water Reclamation intends to seek formal and informal cost proposals to rebuild and/or replace electrical motors, actuators and other related equipment in order to maintain compliance with Ohio EPA's National Pollutant Discharge Elimination System (NPDES) discharge permit, and to provide the necessary redundancy of such equipment as needed. Some equipment may require proprietary parts for rebuild and others can only be purchased from sole sources when needed. For that, the Division is requesting a waiver of all competitive bidding provisions of TMC Chapter 187.

Body: SUMMARY & BACKGROUND:

The City of Toledo entered into a Land Lease Agreement with Sprint Spectrum Realty Company, LLC, pursuant to Ordinance 670-96, passed by the Council of the City of Toledo, September 10, 1996, for the lease of a section of land located at 550 N. Erie St., Toledo, OH, for a self-supporting telecommunications tower, 12' x 28' equipment shelter and fence. The original lease was for an initial seven (7) years with four additional, five (5) year renewal options, expiring September 17, 2023.

This legislation seeks to authorize the Lease Amendment of original agreement to incorporate six additional five (5) year renewal options. Said Lease Amendment shall provide that Sprint Spectrum Realty

Company, LLC pay an annual fee of \$12,592.80, for the 1st additional 5-year term (2023-2028) and an increase of 20% per additional term thereafter for the duration of this Lease Amendment.

The Division of Urban Beautification is charged with the responsibility of cleaning up blight within the City of Toledo. As a response to the public health emergency, and the negative impacts the crisis has had on neighborhood blight, the city will be utilizing Local Fiscal Recovery Funds to support neighborhood clean-up efforts to improve the health and wellness of struggling neighborhoods. On a daily basis, crews from the Division of Urban Beautification are deployed to areas of the city experiencing excess illegal dumping. Crews collect all debris and dispose at the city's Hoffman Road Landfill or work with vendors to recycle appropriate material. The city will track the pounds of debris and number of tires collected on a daily basis using CityWorks software. This Ordinance appropriates \$300,000 for block-by-block clean-up operations.

Declaring the Intent of the City of Toledo to assume and pay assessments for the Ten Mile Creek/Ottawa River

Ditch Petition #1053 and Swan Creek Ditch Petition #1054; authorizing the Mayor to notify the Joint Board of Fulton and Lucas County Commissioners and the Joint Board of Fulton, Henry, and Lucas County Commissioners of the such intent; and declaring an emergency.

Body: SUMMARY & BACKGROUND:

This Resolution authorizes the City of Toledo to assume and pay the assessments for the pending Ten Mile Creek/Ottawa River Ditch Petition and the Swan Creek Ditch Petition. If enacted, the petitions will allow for the maintenance of Swan Creek and its tributaries and the Ottawa River and its tributaries. It will include projects that will include log jam removal and other projects necessary to maintain the waterway, promote stabilization, reduce sedimentation, and improve water quality. As a Home Rule Community under the Ohio Constitution and Section 6131.23(D) of the Ohio Revised Code, a municipality is permitted to assume the assessments on behalf of its residents which permits the municipality to pay the assessments through the performance of projects on the petitioned ditches, through other municipal funds authorized for the purposes of the assessments, or by assessing all or a portion of the assessments to property owners. It is the intent of the Administration to pay the assessments from funds raised through the Stormwater Fee for properties within the City of Toledo.
