**Body:** 

SUMMARY & BACKGROUND:

In 2017, the City of Toledo took ownership of the southern portion of the former Champion Spark Plug site and now wishes to lease it to Crestline Paving. The lease will be a complete 'pass-through or triple net' so that Crestline is responsible for real estate taxes and assessments, maintenance, operating expenses, casualty and liability insurance, and utilities (if and when established like water or telecommunication services) relating to the property. This legislation authorizes the mayor to lease these premises for an annual rent of \$1 with an initial term of five (5) years and one five (5) year renewal option. Finally, no assignments or subleases are permitted without the prior written consent of City.

Authorizing the Mayor to enter into an Easement Agreement with Generations Pipeline, LLC for the grant of an easement for installation, operation, and maintenance of a 16-inch subsurface gas pipeline across a portion of city-owned real estate known as the Collins Park Water Treatment Plant, 3040 York Street, Toledo, Ohio, for purposes of providing natural gas service for the Cliffs Natural Resources, Inc. HBI **Production Project; authorizing the Mayor to execute** needed instruments and agreements in connection with such easement grant; authorizing the Mayor to accept and deposit funds as reimbursement for City incurred expenses associated with the pipeline installation into the Water Operating Fund from Generations Pipeline, LLC in consideration of the easement grant; and declaring an emergency.

**Body:** SUMMARY & BACKGROUND:

The City of Toledo is the fee owner of certain real estate known as the Collins Park Water Treatment Plant located at 3040 York Street, Toledo, Ohio. Generations Pipeline, LLC is in the process of constructing a 16-inch subsurface natural gas pipeline for the purpose of providing natural gas service to the Ironville site. The Ironville site is the location of the construction and operation of Cliffs Natural Resources, Inc. HBI Production Project. The HBI Production Project located in near proximity of the Collins Park Water Treatment Plant will provide economic development, job creation, and an enhanced tax base for the City of Toledo. Generations Pipeline, LLC has requested a subsurface utility easement from the City of Toledo in order to implement the objectives of this Project. Generations Pipeline, LLC has agreed to reimburse the City, as consideration for the easement grant, the associated City incurred costs. The easement grant will encumber a portion of the northwest perimeter of the Collins Park Water Treatment Plant property, however, it has been determined that the easement grant will not conflict with the City's current or anticipated and continuing use of the property or plant operations.

### 1. TMP-3648

Amending the Toledo Municipal Code by repealing Section 2101.01 and enacting a new Toledo Municipal Code Section 2101.01; and declaring an emergency.

#### Body:

#### SUMMARY & BACKGROUND:

Toledo Municipal Code Chapter 2101 governs the terms and conditions of employment for the City of Toledo's Classified Exempt and Executive Exempt employees. This Ordinance repeals Municipal Code Section 2101.01, Classifications, and enacts a new Section 2101.01.

The classifications of Secretary 3 and Mayor's Assistant 2 are unclassified exempt positions, each currently assigned to a salary group 8 in the Toledo Municipal Code, Section 2101.01. This Ordinance would change the classification title of Secretary 3 to "Administrative Assistant." In addition, the salary group for this position would be changed to group 9. These changes are needed because the nature of the position has changed over time to encompass a much greater level of support and work product than those traditionally categorized as "secretarial."

Moreover, maintaining the title of Secretary 3 for this classification is misleading in terms of a career path within the city. The Toledo Municipal Code and the Civil Service Commission provide for two other Secretary classifications: Secretary 1, assigned to salary group 4, and Secretary 2, assigned to salary group 6. A Secretary 3 classification title is misleading in that it appears as if the natural progression in that type of work is from Secretary 1 to 2 to 3. However, since the Secretary 3 classification is an unclassified position subject to appointment and removal by the head of the department, without a competitive process, a natural career path is not typically followed.

Therefore, changing the title of this classification will separate it from the other classified exempt secretary positions and more accurately reflect the modern duties and responsibilities of the position. For similar reasons, the position of Mayor's Assistant 2 would be changed from a salary group 8 to a group 9. That position has likewise been utilized to assist the Mayor's executive staff with tasks that encompass a greater level of support and work product, and the pay level should reflect that.

**Body:** SUMMARY & BACKGROUND:

The American Water Works Association is an international not-for-profit and educational society which advances public health, safety and welfare by uniting the efforts of the full spectrum of stakeholders from throughout the water processing and distribution community. This ordinance authorizes payment of the membership dues for 2019 for the Department of Public Utilities. Funds are provided in the 2019 Operating Budget for this purpose.

#### SUMMARY & BACKGROUND:

In conjunction with the City of Toledo's acquisition of federal and state funding sources for infrastructure improvements, the city also works with and through the TMACOG. The city's 2019 transportation assessment fee to TMACOG for their services is \$51,571. Funds have been budgeted and are available in the 2019 Division of Engineering Services' operating budget to provide for this payment.

The Stormwater Coalition is made up of governments, universities, and non-government groups that contribute annual membership dues to TMACOG. The city's 2019 dues are \$12,058. TMACOG sponsors a yearly educational sampling program for Toledo Area High School students known as the Student Watershed Watch. This funding is used for test kits and student presentation expenses. The city's 2019 contribution to this program is \$9,950. Clear Choices, Clean Water is a water quality educational program for the Greater Toledo Area. This education campaign provides the citizens of northwest Ohio with the information they need to know to take action protecting local waterways. Clear Choices Clean Water helps to fulfill the public involvement, participation, and education requirements that Ohio EPA requires of City of Toledo and other regulated stormwater communities. The city's cost for this 2-year license agreement is \$6,498. Funds for these dues and programs have been budgeted and are available in the 2019 Division of Environmental Services' operating budget to provide for these payments.

Lastly, this ordinance authorizes payment of the city's 2019 general purpose government membership fee from the General Fund. Funds have been budgeted and are available in the 2019 General/Non-Departmental operating budget to provide for this payment.

## **Body:**

#### SUMMARY & BACKGROUND:

The Real Estate Division of the Department of Neighborhood and Business Development has been requested to create the West Toledo Community Reinvestment Area ("WTCRA") to include the area roughly bounded by Tremainsville Rd., Jackman Rd., South Cove Blvd., Torrey Hill, Bancroft, Douglas Rd and the northern boundary of the Toledo School District.

The creation of this CRA will enable the City to provide tax incentives for economic development, job creation and housing investment within the CRA boundary to encourage economic stability, growth and the maintenance of property values. A housing survey has been completed which indicates that there are structures of historical or architectural significance in the designated area, that reinvestment has been discouraged; that there are structures located within the proposed designated area in need of remodeling and areas available for new construction. Ohio Revised Code §§ 3735.65 through 3735.70, as amended, commonly known as the Community Reinvestment Area Tax Exemption Law, permit municipalities to grant real property tax exemptions to encourage the construction and remodeling of structures.

WTCRA exemptions for commercial or industrial property shall be subject to the property owners executing an agreement for payment in lieu of taxes with the Toledo Public Schools, and other requirements specified under the Revised Code and this Ordinance.

Preservation in the proposed designated neighborhoods, rehabilitation, and stability of the neighborhood and commercial areas may be encouraged and advanced by creation of a Community Reinvestment Area. In order to obtain the tax exemption benefit of the Community Reinvestment Area law, the requirements of Sections 3735.65 through 3735.70 of the Ohio Revised Code as amended must be followed in all particulars.

## **Body:** SUMMARY & BACKGROUND:

The Division of Engineering Services has been working closely with TMACOG and ODOT to secure grant funding through multiple funding programs for multiple projects. All amounts are grant dollars and are assigned to specific projects as follows:

A maximum of \$400,000 has been allocated by ODOT through the TMACOG TIP for a resurfacing project; Bancroft Street from I-475 to Holland-Sylvania. Matching funds will be provided through the Ohio Public Works Commission (OPWC) and the Division of Engineering Services Matches and Planning budget.

A maximum of \$1,975,592 has been allocated by ODOT through the TMACOG TIP for a resurfacing project; Lagrange Street from Utica to Oakland. Matching funds will be provided through the Ohio Public Works Commission (OPWC) and the Division of Engineering Services Matches and Planning budget.

A maximum of \$1,549,944 has been allocated by ODOT through the TMACOG TIP for a reconstruction project; York Street from Front to the city limits. Matching funds will be provided through the Ohio Public Works Commission (OPWC) and the Division of Engineering Services Matches and Planning budget.

A maximum of \$2,197,687 has been allocated by ODOT through the TMACOG TIP for a reconstruction project; Douglas Road from Laskey to Alexis. Matching funds will be provided through the Ohio Public Works Commission (OPWC) and the Division of Engineering Services Matches and Planning budget.

A maximum of \$400,000 has been allocated by ODOT through the TMACOG TIP for a reconstruction project; Central Avenue from Brigham to Buckeye. Matching funds will be provided through the Ohio Public Works Commission (OPWC) and the Division of Engineering Services Matches and Planning budget.

A maximum of \$2,839,200 has been allocated by ODOT through the ODOT Urban Paving Program for a roadway resurfacing project; State Route 184 (Alexis Road) from Jackman to Flanders. Matching funds will be provided through the Ohio Public Works Commission (OPWC) and the Division of Engineering Services Matches and Planning budget.

A maximum of \$610,364 has been allocated by ODOT through the TMACOG TIP for an enhancement project; Summit Street Enhancement from Lagrange to Chestnut. Matching funds will be provided through the Division of Engineering Services Matches and Planning budget.

The matching funds will be proposed in the Division of Engineering Services 2019 Matches and Planning budget and the TIF budget that will be covered by separate ordinances.

Passage of this ordinance is required to enable the City of Toledo to accept outside funding for these projects and have it in place to help pay for these expenditures.

## **Body:** SUMMARY & BACKGROUND:

This ordinance authorizes the mayor to accept, deposit, appropriate and expend up to \$2,581,970 in grant and loan funds from the Ohio Public Works Commission (OPWC). It further authorizes the mayor to enter into agreements for the referenced grants and loans and to conduct the appropriate budget adjustments and transfers of expense associated with said grants and loans. It further dedicates a source of funds for repayment of the loans.

Resolutions #430-17 and #418-18 authorized applying for this assistance and entering into an agreement with OPWC for this purpose. Sections 1 and 3 of this ordinance details each project's grant and/or loan amount and account code.

Each of these projects requires match money which is either in place or will be in place through other city or outside funding sources.

Passage of this ordinance is required to enable the City of Toledo to accept OPWC funding and to proceed with the construction of these projects.
