COUNCIL MEMBER SPANG PRESENTS:

[TMP-3682](#) Authorizing the expenditure of \$15,716.77 from the General Fund for the 2019 dues for the National League of Cities; and declaring an emergency.

Body: SUMMARY & BACKGROUND:
The National League of Cities offers an unparalleled portfolio of benefits including learning how to save money and time, participate in educational opportunities that can help the City excel as a leader, and access creative ideas and best practices to resolve our challenges.

This ordinance authorizes the payment of \$15,716.77 to the National League of Cities for the 2019 dues. Funds are available in the City Council budget for this expenditure.

DEPARTMENT OF NEIGHBORHOODS:

2. [TMP-3671](#) Authorizing the Mayor to enter into an agreement with

Midwest Environmental, Inc. for the abatement of environmental contaminants and removal of debris at 532 Woodville Rd., as declared an emergency demolition by the Building Official, in an amount not to exceed \$23,000; and declaring an emergency.

Body: SUMMARY & BACKGROUND:

The City of Toledo has sought a contractor with the appropriate equipment to abate an immediate nuisance at the address of 532 Woodville Rd., Toledo 43605. The structure was assessed to have 3 living-units, with a commercial storefront attached; totaling 2,476 sq ft of structure space. The structure was subject to a fire and partial collapse on August 22, 2018; which resulted in an emergency order issued from the Building Official. The pile of debris contains environmental contaminants which require methodical removal from a licensed abatement company under the direction of the Ohio EPA.

DEPARTMENT OF FIRE & RESCUE OPERATIONS:

3. [TMP-3677](#) **Authorizing the Mayor to execute a County Wide Emergency Medical Services Agreement between the Board of Commissioners of Lucas County, City of Toledo and other Lucas County subdivisions; authorizing the acceptance and deposit of payments; and declaring an emergency.**

Body: SUMMARY & BACKGROUND:

The City of Toledo Fire and Rescue Department operates five (5) full time Lucas County Advanced Life Support Life Squads and one (1) part-time Advanced Life Support Life Squads seven days a week, in compliance with standards, regulations, and requirements established and monitored by the County. Emergency medical communications and paramedic life squad systems in Lucas County are a matter of public health and safety. It is the desire of the City of Toledo to enter into an agreement to provide emergency medical services to the residents of Lucas County in conjunction with Lucas County

Emergency Medical Services (EMS) on a coordinated, county wide basis ("Agreement").

Lucas County shall compensate Toledo for the cost of operating and staffing the Life Squads. The compensation rate for each full time Advanced Life Support Life Squad will be \$201,099.03 for each full quarter and \$125,686.89 for each full quarter for the part-time Advance Life Support Life Squad. Total annual compensation to Toledo under the Agreement is approximately \$4,524,728 million. This Agreement continues the existing county wide EMS operational relationship between Lucas County Board of Commissioners and other Lucas county subdivisions. The Agreement is effective January 1, 2019 through December 31, 2019, with an option to extend the Agreement on a quarterly basis.

DEPARTMENT OF POLICE OPERATIONS:

4. [TMP-3672](#) **Authorizing the Mayor to enter into an Agreement with Beren Equipment Co. LLC.; Authorizing the Toledo Police Department to receive \$220.50 for each Salvage Vehicle removed from the Toledo Police Impound Lot; Authorizing the Deposit of the Funds received for salvage vehicles to the Toledo Police Impound Lot account; and declaring an emergency.**

Body: This ordinance authorizes the Mayor to enter into an Agreement with Beren Equipment Co. LLC dba Cherry Picked Auto Parts for the removal of salvage vehicles from the Toledo Police Impound Lot. A competitive bid was posted on Planet Bids and Beren Equipment Co. LLC submitted the best overall bid.

Authorizing the Mayor to enter into a five-year agreement with Axon Enterprises Inc.; authorizing the Law Enforcement Trust Fund expenditure of an amount not to exceed \$269,720 for the first year and \$349,920 from the general fund for each of the remaining four years subject to future appropriations; waiving the competitive bidding requirements of TMC Chapter 187; and declaring an emergency.

Body: SUMMARY & BACKGROUND:

This ordinance authorizes the Mayor to enter into an agreement with Axon Enterprises Inc. for a five-year agreement for the Taser 7 (CEW) Conducted Energy Weapon. This contract will enable the department to reliably budget for the total costs related to Tasers. The contract covers the costs of the Taser, holster, batteries, data storage, inventory management, maintenance, cartridges, and training for five years. There is significant cost savings to the City of Toledo over the life of this agreement. Axon is the sole source manufacturer of Taser products.

DEPARTMENT OF PUBLIC UTILITIES:

Authorizing the appropriation and expenditure of \$1,000,000 from the unappropriated balance of the Franklin Park/Westfield Municipal Public Improvement Tax Increment Fund for two construction projects; and declaring an emergency.

Body: SUMMARY & BACKGROUND:

Ohio Revised Code Sections 5709.40, 5709.42 and 5709.43 provide City Council with the authority to dedicate real estate tax proceeds on specific parcels towards infrastructure improvements in the vicinity of

those parcels. In 2004, to improve safety conditions and reduce hazards to vehicular traffic associated with the expansion of the Westfield Mall and Westgate Shopping Center, City Council passed Ordinance 810-04 enabling tax proceeds from properties in these areas to be dedicated to infrastructure improvements in their respective vicinities.

This ordinance authorizes appropriation and expenditure for the construction of roadway improvement projects as follows:

A roadway resurfacing project for Laskey Road from Harvest to Secor and a safety improvement project at the intersection of Laskey and Talmadge.

Authorizing the Mayor to enter into a joint cooperation agreement with the Metropolitan Park District of the Toledo Area for the Ottawa Street sidewalk project; authorizing the acceptance, deposit, appropriation and expenditure of an amount not to exceed \$16,666 from the Metropolitan Park District of the Toledo Area into the Capital Improvement Fund for the construction of sidewalk on Ottawa Street; authorizing the mayor to enter into contracts for said project; and declaring an emergency.

Body: SUMMARY & BACKGROUND:

The Division of Engineering Services is partnering with the Metropolitan Park District of the Toledo Area to extend the sidewalk on the west side of Ottawa Street from the vicinity of the Oliver House to the new Middlegrounds Park in 2019. This existing gap in the sidewalk system in this area hampers safe pedestrian access to the park. The Metropolitan Park District of the Toledo Area has agreed to fund a share of the project and has committed to reimburse the City of Toledo 33% of the costs, up to \$16,666, for these improvements. The City of Toledo portion of the costs will be paid for with CIP

matches and planning funds.
