Authorizing the appropriation of \$1,250,000 from the unappropriated balance of the Capital Improvement Fund for the 2019 Sidewalk Program; authorizing the expenditure of \$1,250,000 from the Capital Improvement Fund for the 2019 Sidewalk Program; authorizing the Mayor to prepare plans and specifications, acquire required rights-of-way as appropriate, and enter into contracts for this project within the Division of Engineering Services; and declaring an emergency.

Body: SUMMARY & BACKGROUND:
The 2019 CIP Plan (Ord. 42-19) appropriates \$800,000 for the 2019 Sidewalk Program. The Administration also projects an Assessed Improvement Fund amount of \$448,000 for the 2019 Sidewalk

Program. These amounts are not nearly sufficient to address the long listing of sidewalks needing replacement as maintained by the Division of Engineering Services.

The additional funds of \$1,250,000 included in this ordinance are for work to be scheduled for 2019. These additional funds will increase the total 2019 Sidewalk Program to \$2,498,000. Authorization for appropriation and expenditure of these additional funds now will allow for timely bidding and construction to ensure all projects are completed this year in a balanced, efficient fashion.

Declaring a Moratorium until December 31, 2019, on the authority of the Toledo-Lucas County Plan Commission to accept applications for Special Use Permits for Residential Drug & Alcohol Treatment Facilities within Council District 4; and declaring an emergency.

Body: SUMMARY & BACKGROUND:

Toledo City Council by Ordinance 147-18 declared a moratorium on the authority of the Toledo-Lucas County Plan Commission to accept applications for Special Use Permits for Residential Drug and Alcohol Treatment Facilities within Council District 4. The moratorium was extended to April 15, 2019, pursuant to Ordinance 402-18. The purpose of this moratorium is to allow Council to study what adverse impact, if any, the concentration of Residential Drug & Alcohol Treatment Facilities has on neighborhoods in Toledo, particularly with regard to traffic congestion, criminal activity and the maintenance of housing in the vicinity of such facilities. The Plan Commission staff has completed the study and it was presented at the Toledo City Planning Commission meeting on February 14, 2019. It will be presented to the Toledo City Council Zoning and Planning Committee on March 20, 2019, before being presented to the full Council. An extension of the

moratorium will be needed to provide Council with adequate time to review the study and recommendations of the Plan Commission.

Body: SUMMARY & BACKGROUND:

This Ordinance authorizes an agreement between Toledo Municipal Court and the Pathway, Inc. for the provision of employment program services to criminal defendants in the Toledo Municipal Court. The Agreement is for a one-year term with an option to extend the agreement for an additional two years subject to the availability of funds.

Authorizing the Mayor to execute an amendment to the memorandum of understanding regarding Toledo's fire services agreement with the Village of Ottawa Hills; and declaring an emergency.

Body: SUMMARY & BACKGROUND:

In an effort to promote regional cooperation and to improve efficiencies in the mutual provision of public service, the City of Toledo and the Village of Ottawa Hills (VOH) entered into a Fire Services Agreement ("Agreement") to combine firefighting services under the control of the City of Toledo. Pursuant to the 20 year agreement, authorized by Ord. 17-2011, the Toledo Fire and Rescue Department ("TFRD") absorbed the facilities, equipment and full-time personnel of

the VOH Fire Department. The agreement required TFRD to occupy and man the fire station in VOH and for the VOH to pay the City an annual service fee.

TFRD determined the VOH territory could be covered from stations located within the City of Toledo without any negative effect on the quality of service to the VOH. Moreover, it is anticipated that TFRD would realize savings if it were no longer required to man a station it believes is superfluous in terms of coverage. As authorized by Ord. 364-18, VOH and the City of Toledo entered into a Memorandum of Understanding (“MOU”) temporarily modifying the original Agreement by creating a six month trial period to determine what if any impact the new coverage will have on the VOH. During the first six-month trial period, payment under the Fire Services Agreement was suspended. The trial period under the MOU is set to expire March 31, 2019.

After reviewing TFRD responses into Ottawa Hills, it is recommended that the trial period under the MOU be extended for another six months. The reason for the extension is that due to the low volume of incidents in Ottawa Hills, an adequate amount of response data has not been obtained to allow for an educated decision on the impact of the change. Should the results of trial period prove acceptable, an amendment would be drafted to the Agreement that would make the arrangement permanent for the remainder of the Agreement term and determine a revised fair and reasonable annual service fee to be paid by the VOH.

This ordinance authorizes the Mayor and TFRD to execute an amendment to the MOU to extend the trial period for an additional six months and sets a fee of \$130,000 for TFRD services for the extension period.

Establish an OVI Trust Fund for court imposed fines for operating a vehicle under the influence of alcohol or drugs (OVI); authorizing the acceptance, deposit and appropriation and expenditure of the OVI Trust Fund proceeds in compliance with Ohio Revised Code 4511.19 for costs incurred enforcing OVI law and informing the public of the dangers of operating a vehicle under the influence of alcohol and or drugs; and declaring an emergency.

Body: SUMMARY & BACKGROUND:

This ordinance authorizes the Mayor to establish an OVI Trust Fund for court fines imposed under ORC 4511.19. This ORC section dictates that these fines shall be paid to an enforcement and education fund established by the legislative authority of the law enforcement agency in this state that primarily was responsible for the arrest of the offender, as determined by the court that imposes the fine. The agency shall use this share to pay only those costs it incurs in enforcing this section or a municipal OVI ordinance and in informing the public of the laws governing the operation of a vehicle while under the influence of alcohol, the dangers of the operation of a vehicle under the influence of alcohol, and other information relating to the operation of a vehicle under the influence of alcohol and the consumption of alcoholic beverages.

Body: SUMMARY & BACKGROUND:

The Toledo Police Department has requested and received an additional \$42,517.60 in Ohio Drug Law Enforcement Fund grant funds from the Ohio Office of Criminal Justice Services to conduct drug investigations. The original grant was for \$44,126.22 (ORD. 313-18).

There is a match of \$14,173.70 required for this addition to the grant, which will be met by personnel salaries. The grant funds will increase the department's ability to conduct drug enforcement investigations.

Body: SUMMARY & BACKGROUND:
Ordinance 442-18 authorized the receipt and expenditure of a United States Bureau of Justice Assistance Technology Innovation for Public Safety (TIPS) grant in the amount of \$492,553 for gun and violent crime reduction programs.

This ordinance authorizes a \$310,000 contract with SST, Inc. for Shot Spotter. SST, Inc. is the global leader in gunfire detection and location technology providing the most trusted, scalable and reliable gunfire alert and analysis available today. Shot Spotter uses an array of acoustic sensors that reliably detect and accurately locate gunshots. No vendor, other than SST, Inc., possesses the comprehensive, field-proven, and patent-protected product offering, as well as the professional services and support, domain knowledge, expertise, longevity, and customer references. Only SST, Inc. can provide a true wide-area gunshot detection, location, alert and analysis solution, as well as future expansions and ongoing maintenance and support.

This ordinance authorizes the Mayor to enter into an agreement with Savant Learning Systems, Inc. for a subscription to the Virtual Academy Training Management System. The Virtual Academy Training Management System (TMS) is a fully integrated, cloud-based training management solution. This system provides officers with the ability to attend training in a web-based environment rather than requiring officers to be scheduled out of service for training. This system enables a more efficient use of each officer's time for training by reducing the amount of time they are out-of-service. A bid was posted on Planet Bids for the purchase of a learning management system and Savant Learning Systems, Inc. Virtual Academy was the winning bidder.

Body: SUMMARY & BACKGROUND:

The Toledo-Lucas County Victim-Witness Assistance Program has requested funding to continue its services to residents of Toledo and Lucas County. The Toledo-Lucas County Victim-Witness Assistance Program assists victims of violent crime as they go through the criminal justice process. This ordinance authorizes the expenditure of \$40,000 for the contribution from the Police Law Enforcement Trust Fund. There are no impacts on general fund expenses or revenues.

7. [TMP-3769](#) **Authorizing the appropriation of \$450,000 from the unappropriated balance of the Stormwater Utility Improvement Fund and operating transfer of same to the Stormwater Utility Operating Fund; authorizing the appropriation and expenditure in an amount not to exceed \$450,000 from the unappropriated balance of the Stormwater Utility Operating Fund; authorizing the mayor to enter into a contract with Woolpert, Inc. for the completion of the Stormwater Billing update and Impervious Surface Mapping Phase 1; and declaring an emergency.**

Body: SUMMARY & BACKGROUND:
The Stormwater Utility charges a stormwater fee for properties with impervious surfaces within the City of Toledo. Residential Customers (single family homes and duplexes) are billed at a flat rate of 1 Equivalent Residential Unit (ERU), while non-residential customers are billed based on a measurement of the impervious surfaces on their property. The impervious surface of each non-residential property was digitally traced (digitized) into GIS using an aerial photo background to obtain the square footage. These measurements have been updated manually as the city has become aware of site improvements or measurement errors on individual parcels, however, there has not been an overall review or update of the billing measurements for the entire city.

This ordinance appropriates funds for phase one of a two phased project to ensure consistent and fair stormwater billing to all City of Toledo residents. This phase will review the current policies for stormwater billing, perform impervious surface mapping using remote sensing technology, and update the City's Equivalent Residential Unit (ERU) database. Phase 2 of this project will merge the ERU database and the City of Toledo Billing database (SAP), along with including a process and procedure to keep the two databases in sync, and performing a cost of service analysis of the Stormwater Utility.

Authorizing the mayor to renew contracts with Taylor Excavating in the amount of \$1,250,000 for the purpose of providing water and sanitary sewer kills for the City of Toledo, Lucas County Land Reutilization Corporation, and private demolition projects; authorizing the expenditure from the Water Operating Fund, the Sewer Operating Fund, and the Expendable Trust Fund; and declaring an emergency.

Body: SUMMARY & BACKGROUND:

In compliance with Toledo Municipal Code (TMC) Section 927.13 and Section 107.03; whenever a building is demolished, sewer and water is taken out of service, the connection to the public sewer and water services shall be plugged (killed) at the tapping or opening into the public sewer/water main. To execute this process, the Division of Sewer and Drainage Services bid out and awarded price determining contracts with the lowest bidder, Taylor Excavating, as authorized under Ordinance 95-18, to perform sewer and water service kills for the City of Toledo, Lucas County Land Reutilization Corporation, and private demolition projects through utilization of the Water Operating Fund, Sanitary Sewer Fund, and Expendable Trust Fund. In order to maintain 2018 pricing, Taylor Excavating and Sewer and Drainage Services desire the renewal of the existing contract for Sewer and

Water Kills. There is no additional financial impact to the City of Toledo as these funds were budgeted for the 2019 budget.

Parts are no longer available for maintaining this system that is essential for keeping our sewer cleaning trucks and pumps from freezing in the winter.

TMC 187 requires Council to be informed of the emergency and for authorization to pay the repair. Sufficient funds are available within the DPU operating budget to pay for this emergency combine sanitary sewer repair.

Authorizing the Mayor to enter into a Real Estate Purchase Agreement with Torrey Hill Apartments, LLC and to execute and deliver needed instruments for the sale and conveyance of certain city-owned real property at 336 14th Street in the City of Toledo, Lucas County, Ohio; waiving the competitive bidding and advertising provisions of TMC 187.19; authorizing the deposit of \$300,000; authorizing the Mayor to execute and deliver the needed instruments to release the mortgage in whole, on the Low Income Housing Tax Credit Project for the 52-unit multi-family rental housing complex called Torrey Hill Apartments, LLC; making certain findings with respect thereto; and declaring an emergency.

Body: SUMMARY & BACKGROUND:

The City of Toledo is the fee simple owner of certain real property located at 336 14th Street in the City of Toledo, Lucas County, Ohio. The property consists of one parcel (TD 15-50317) and is approximately 0.8982 acres of land. The improvement on the real property is currently owned by Adams Street Limited Partnership, LLC. It is known as Uptown Arts Apartments, LLC, which is a 52

-unit affordable multi-family complex consisting of one-two-and three-bedroom garden and townhouse style apartments.

In order to facilitate the development of the complex in the early 2000s, the City entered into a 90 year ground lease agreement with Adams Street Limited Partnership, LLC and provided a HOME Investment Partnerships Program loan to assist in the financing of the project. In exchange for the HOME loan a certain number of units are required to be affordable for a period of time.

In addition to the City's assistance, the project was awarded Low-Income Housing Tax Credits. The Low-Income Housing Tax Credit program (LIHTC) is a public policy tool used to provide funding for the development of affordable housing. The federal government allows developers of particular affordable-housing projects to sell tax credits to investors to provide the capital necessary to build the project. In exchange for the LIHTC a certain number of units are required to be affordable for a certain period of time.

Adams Street Limited Partnership, LLC, the current owner of the improved property, intends to sell its interest to Torrey Hill Apartments, LLC. The prospective buyer wishes to acquire the City's fee simple interest in order to obtain primary financing for the acquisition and redevelopment of the structure. The purchase price for the City's fee simple interest is \$300,000 (THREE HUNDRED THOUSAND DOLLARS).

The purchaser, Torrey Hill Apartments, LLC intends to modernize the complex while keeping existing residents in place and adhering to the affordability requirements stipulated by the Ohio Housing Finance Agency and City of Toledo.

As part of the agreement to release the mortgage, the City of Toledo, Department of Neighborhood and Business Development is requiring that five (5) of the units remain affordable to tenants earning less than or equal to 60% of the Area Median Income (AMI). Rent restrictions will remain on the five units until December 31, 2022. The

City's restrictions are in addition to those stipulated by OHFA, which are outlined in the attached Fourth Amendment.

Torrey Hills Apartments, LLC's development proposal benefits the community by improving the quality of the neighborhood through comprehensive capital investments and protecting the existing residents either at or above the standards set by relevant housing authorities.

Body: SUMMARY & BACKGROUND:

Crack Sealing is a cost efficient pavement preventive maintenance technique that can greatly expand the service life of city streets. The City of Toledo has conducted minor Crack Sealing Programs in the past, averaging 81 lane miles a year, with the most recent program conducted in 2017. The Division of Streets, Bridges & Harbor, in cooperation with the Division of Engineering Services, is proposing to operate a spring and fall Crack Sealing Program to address deferred maintenance of city streets. This would allow for eligible streets to be crack sealed within a timely manner. The City of Toledo will contract out major arterial roads and some residential streets while Division of Streets, Bridges & Harbor crews will crack seal other residential and minor arterial streets. The Division of Streets, Bridges & Harbor has \$200,000 in its existing 2019 operating budget, appropriated by Ordinance 26-19 from the SCM&R Fund for the 2019 Crack Sealing Program.

This Ordinance authorizes the expenditure of monies from Forestry Assessed Funds to address a population of destructive gypsy moth caterpillars. The City of Toledo has a submitted and approved application with the Ohio Department of Agriculture (ODA) to participate in Ohio's Gypsy Moth Suppression Program to treat a total of 345 acres within the City of Toledo. These areas include blocks of

Alexis, Copland, Kenmore, Longfellow, as well as sections of Ottawa Park and Walbridge Park. Application is currently planned for mid-May. Application timing depends on the instar stage of the Gypsy Moth caterpillar, the amount of canopy the trees have deployed, and weather conditions.

Body: SUMMARY & BACKGROUND
The purpose of the grant is to assist communities in addressing the challenges of obesity, rising incidence of chronic disease and the aging workforce. This program will assist the City of Toledo with the creation and implementation of a workplace wellness program. The goal is to limit and control the escalating cost of workers' compensation claims and to develop health promotion programs for employees, which will also reduce healthcare costs for employers and improve the health and well-being of our workforce.

The grant will allow the city to use the funds for wellness initiatives such as health risk appraisals, biometric screenings, walking programs, educational materials and disease prevention.

Body: SUMMARY & BACKGROUND:

Voters participating in a special election held on February 26, 2019, passed an amendment to the City of Toledo Charter titled Lake Erie Bill of Rights (“LEBOR”). Drewes Farm Partnership filed on February 27, 2019, a lawsuit in the U.S. District Court, Northern District of Ohio, against the City of Toledo. The lawsuit generally alleges that the amendment is unconstitutional and violates Ohio and federal law.

As the result of the potential for a conflict of interest, it is necessary to retain outside counsel to assist the City in this litigation. This ordinance seeks authorization for monies to pay outside counsel.

Authorizing the Mayor to execute and deliver needed instruments waiving the city’s reservation of a right of first refusal for the proposed sale of 3201 Stickney Ave. by the James C. Caldwell Community Center; and declaring an emergency.

Body: SUMMARY & BACKGROUND:

In 1985, pursuant to Ordinance 300-85, the City of Toledo conveyed 3201 Stickney Ave., the former Fire Station 19 property, now known as the Caldwell Community Center, (“Property”) to the North Toledo Community House, subsequently the James C. Caldwell Community Center, a non-profit organization serving community needs of north Toledo residents. The 1985 deed conveying the Property includes a reservation by the city of a right of first refusal should the Community Center wish to subsequently convey the Property to a third party. The

Community Center has now agreed to sell the property to the Toledo/Northwestern Ohio Foodbank, Inc. ("Foodbank"). The Foodbank plans to use the Property in furtherance of its charitable purpose. The purchase is being made at the Property's appraised value as determined pursuant to an appraisal dated 12/23/15 obtained by the Toledo/Northwest Ohio Foodbank.

The city administration supports the purchase and use of the building by the Toledo/Northwest Ohio Foodbank and does not wish to exercise the city's right of first refusal provided under the 1985 deed. This ordinance authorizes the Mayor to waive and elect not to exercise its right of first refusal and waive the 45-day notice period as specified in the deed reservation.
