The West Oak Walk Business Association (WOW), a business organization in District 5, submitted a District Improvement Program application for the installation of eleven (11) decorative light posts on the north side of Sylvania Avenue between Douglas and Secor to enhance the quaintness of the business district. The lights would be in addition to the current light inventory, but would be more energy efficient and would be the first decorative lights in the area. Additionally, WOW proposes upgrading the existing thirty (30) streetlights to light emitting diode (LED) lighting for aesthetics and security. The District Improvement Review Committee convened on April 4, 2019, and recommended approval of this application in an amount not to exceed \$115,320.

This Ordinance authorizes the reappropriation of funds within the Toledo City Council budget. Funds are available in the City Council personnel services budget for summer internship positions through the City's collaboration with the University of Toledo and the Toledo Talent Makes Toledo Great Program. Interns hired through this program remain independent contractors and as such must be paid from a contractual services account. This Ordinance reduces the personnel services budget and increases contractual services to fund

the summer internships.

COUNCILMAN RILEY PRESENTS:

TMP-4023 Amending Toledo Municipal Code, Part Eleven,

Subsections 1104.0600 and 1116.0217; enacting new

Subsections 1104.0600, 1116.0217 regarding

convenience stores; and declaring an emergency.

Body: SUMMARY & BACKGROUND:

The request is a Text Amendment to TMC§1104.0600 *Convenience stores* and TMC§1116.0217 *Food and Beverage Retail Sales* and is intended to add text regarding convenience store facilities.

The goal of the amendment is to address the economic, health, and safety concerns associated with the concentration of convenience stores and their impact on residents of Toledo. Convenience store use regulations were initially enacted in 2004 to control the secondary effects on crime and blight associated with these businesses. Since that time, the convenience store model has grown to include stores in excess of 5000 square feet. These stores are proliferating with no spacing, litter or congestion elimination restrictions in place.

The proposed text amendment will not impact any existing convenience stores established in the City of Toledo, however any new convenience stores will be subject to the proposed legislation. As stated in TMC§1101.0400, the Zoning Code is intended protect the health, safety, and general welfare of the citizens of Toledo.

The West Oak Walk Business Association (WOW), a business organization in District 5, submitted a District Improvement Program application for the installation of eleven (11) decorative light posts on the north side of Sylvania Avenue between Douglas and Secor to enhance the quaintness of the business district. The lights would be in addition to the current light inventory, but would be more energy efficient and would be the first decorative lights in the area. DEPARTMENT OF NEIGHBORHOOD & BUSINESS DEVELOPMENT:

1. TMP-3998 Authorizing the mayor to enter into a Real Estate

Purchase Agreement with Estes Express Lines ("Estes") and to execute and deliver needed instruments for the sale and conveyance of approximately 47.9 acres of city-owned real property at Capital Commons, in Toledo, Lucas County, Ohio; making certain findings with

respect thereto; waiving the competitive bidding and advertising provisions of TMC 187.19; authorizing the

deposit of net sale proceeds into the Property Management Fund; authorizing the deposit,

appropriation, and expenditure of \$50,000 from the net

sale proceeds from General Fund to the Capital Improvements Fund to pay for road improvements; Authorizing the mayor to enter into a separate agreement with and to accept additional financial assistance from the State of Ohio, Department of Transportation (ODOT), in an amount not to exceed \$75,000 for improvement to Capital Commons Drive; authorizing deposit, appropriation, and expenditure of the grant proceeds from the General Fund to the Capital Improvements Fund; authorizing the mayor to accept bids and award contracts for said project; and declaring an emergency.

Body: SUMMARY & BACKGROUND:

The City of Toledo is the owner of certain real property located in South Toledo known as Capital Commons located at 5600 Angola Road as shown in Exhibit A ("Real Property"). An offer from Estes to purchase approximately $47.9\pm$ acre Capital Commons property for \$424,760 or \$8,500 per acre has been presented and should be accepted.

Estes is a logistics and distribution company currently located in a 50,000 square foot terminal facility at 5330 Angola Road Toledo, Ohio 43615. As a result of Real Property sale, Estes has promised to expand its operations onto the property, retain 193 jobs, and create 15 new jobs.

As part of the sale of this property and the expansion of the company's operations, improvements will be made to Capital Commons Drive. The State of Ohio through its Jobs and Commerce grant funding will assist with \$75,000.00 for improvements to Capital Commons Drive. The City should pay no more than \$50,000 from the sale proceeds for these road improvements. The City has also agreed to pay closing costs of approximately \$21,900.00 for Current Agricultural Use Valuation ("CAUV") recapture expenses, and \$42,276 Reichle Klein Group in commission fees.

2. TMP-3954

Authorizing the Mayor to enter into a five-year contract with Enterprise Fleet Management for vehicle replacement with an option to renew for an additional five years; authorizing the annual expenditure from various funds over the life of the agreement; waiving the competitive bidding requirements of TMC 187; and declaring an emergency.

Body:

SUMMARY & BACKGROUND:

Operating expenses associated with the city's fleet are continuing to rise as our fleet ages. With limited capital funds, the city is pursuing a fleet management lease option for replacing our fleet. Enterprise Fleet Management has been awarded the fleet management Sourcewell contract. Enterprise Fleet Management offers a municipal lease that will allow the city to replace a larger portion of our aging fleet with similar or less capital expenses. Enterprise will assist the city in establishing the most cost effective lifecycles and offer flexibility of ownership. The program will improve the safety and reliability of our fleet and offers the potential to reduce operating expenses. The Division of Fleet will start a trial program with Enterprise for vehicle replacement in the Division of Engineering and Division of Transportation using \$140,000 of previously approved funds. Ordinance 478-18 authorized the expenditure of \$50,000 for the purchase of supervisor vehicles for the Division of Transportation, while Ordinance 184-18 authorized the expenditure of \$60,000 from the Water Replacement Fund, \$19,800 from the Storm Water Utility Operating Fund, and \$10,200 from the Storm Water Utility Replacement Fund for purchase of vehicles and equipment. This legislation is authorizing the Division of Fleet to use the appropriated funds from various funds for the trial lease program of new vehicles and equipment for City divisions.

Body:

SUMMARY & BACKGROUND:

The Division of Streets, Bridges & Harbor utilizes semi-trucks within the demolition program. These trucks are commonly used to haul large equipment to a worksite and back to the storage building. Also, at times, the trucks are utilized to haul demo debris from the worksite to the landfill.

The division currently has four (4) semi-tractors in its inventory for demolition work, with the possibility of using any one (1) of nine (9) demolition trailers and four (4) open-bed haul trailers. The current demolition program, which is partnered with the Lucas County Land Bank, is expected to end late summer of 2020. By purchasing used semi-tractors, the city will save money and also be able to ensure the completion of the program in a timely manner. Purchasing one (1) new semi-tractor would cost approximately \$125,000 and would take nine (9) months or more to receive.

The Department of Neighborhood and Business Development-Real Estate oversees the review and processing of the program. Body: SUMMARY & BACKGROUND:

On December 15, 2017 Susan Schlageter was injured when the vehicle she was driving was struck by a Toledo police car driven by a Toledo police officer. At the time of the accident the officer was performing duties for the Toledo police department.

A proposed agreement has been reached in the amount of \$270,000.00 to settle all remaining claims resulting from the incident described herein without constituting an admission of liability for any violation of state or federal law. Specifically, the settlement is for payment to both Susan Schlageter and her husband Thomas for his related consortium claims.

Authorizing the mayor to pay the annual fee to the Petroleum Underground Storage Tank Release Compensation Board (PUSTRCB) in the amount of \$9,100 for qualifying city-owned underground petroleum storage tanks; authorizing the expenditure for 2019 annual fee from the Risk Management Fund; and declaring an emergency.

Body: SUMMARY & BACKGROUND:

Chapter 3737 of the Ohio Revised Code (ORC) established the Petroleum Underground Storage Tank Release Compensation Board (PUSTRCB) and Petroleum Underground Storage Tank Financial Assurance Fund (PUSTAF). The purpose of the Board is to allocate funds to reimburse owners and operators of qualifying underground storage tanks, the costs of corrective actions and compensation paid to third parties resulting from releases of petroleum from those tanks less applicable deductible. Pursuant to the ORC Section 3737.91, the City is required to pay an annual fee for the purpose of implementing, administering, and enforcing that program.

Fees are assessed at \$350 per tank. The City owns/operates 26 qualifying petroleum underground storage tanks, and the annual fee in the amount of \$9,100 is now due and payable. Payment received after July 1st of each year is subject to penalties.

This ordinance authorizes the mayor to complete the necessary forms and pay the 2019 fee from the Risk Management Fund. These funds are included in the annual operating budget.

Establishing and implementing a program to provide an annual fire operational inspection permit for mobile food units and charging a permit fee; authorizing the acceptance and deposit of revenues in the General Fund; and declaring an emergency.

Body: SUMMARY & BACKGROUND:

December 31, 2017 the State Fire Marshal's office enacted Ohio Fire Code Section 320 establishing operational provisions for Mobile Food Units. This extensive code applies to all mobile food units operated within this state. In addition to other applicable provisions of this code, all mobile food units being operated in this state shall comply with the provisions of this code for the type of cooking performed.

To assure compliance with the provisions of this code, The Toledo Fire and Rescue Department seeks to implement an annual fire operational inspection adhering to the provisions set by this state fire code, and issuing a permit for mobile food units operating within the boundaries of the City of Toledo as set forth in TMC 746.02 "General Operational Standards for Mobile Food Vendors."

The Toledo Fire and Rescue Department desires to assess a \$150 (One Hundred Fifty Dollar) fee for each annual inspection. This fee will

help offset the cost of the annual inspection and the state mandated sight inspection each time a mobile food unit is set up to operate.

The Space Usage Agreement defines space usage on the campus and provides to pay the amount to Owens Community College for the Law Enforcement Center Building used by the Toledo Police Academy. Funds for this expenditure are included in the annual operating budget. This agreement will be in effect from July 1, 2019 through June 30, 2021.

He will assist the project staff with the identification of the problem, selection of an evidence-based solution, implementation of the project, and evaluation of the project's effectiveness through performance measures. This agreement will be for \$30,000 with payment from the United States Bureau of Justice Assistance Technology Innovation for Public Safety (TIPS) grant, previously approved by Ord. 442-18.

PAL has been operating at this location since 2016.

SUMMARY & BACKGROUND:

The city maintains a blanket "all-risk" insurance policy covering its property. Fireman's Fund Insurance Company has provided insurance coverage for the city for over five years. Since the last ordinance was passed in May 2018, the Hylant Group has priced the market and negotiated a lower rate charged to the city for the same insurance coverage with Fireman's Fund Insurance Company; offering the same coverage limits, as well as maintaining the lower deductible for the insurance coverage of the city's sewer lines at a substantially lower rate/premium.

As a direct result, Fireman's Fund Insurance Company offers the maximum and best coverage, inspection and engineering support at the lowest premium cost.

The last ordinance authorizing the Mayor to enter into a contract for property insurance was passed in May 22, 2018. The authorization now is for one year with the option of renewing for three additional one-year periods. This commitment, from the City to Fireman's Fund Insurance Company, and from Fireman's Fund Insurance Company to the City, serves as the basis for the most favorable outcome both in coverage and in working with the City to further develop and implement loss prevention measures.
