Amending Ordinance 20-20 to update the funding sources for the 2020 Matches & Planning Program; and declaring an emergency.

Body:

SUMMARY & BACKGROUND:

Ordinance 20-20 approved the appropriation and expenditure of \$5,900,000 for 2020 major roadway Matches & Planning Program. As approved the Program was funded through the Capital Improvement Fund. This ordinance amends ordinance 20-20 to fund a portion of the Program through the Street Construction, Maintenance and Repair Fund (SCMR). Amending ordinance 20-20 to update the funding source will maintain consistency with the proposed amendments to the Capital Improvement Plan budget for 2020.

O-077-20

Authorizing the Mayor to award a contract for a period not to exceed five years for the implementation of and licensing for an online vendor portal software solution; authorizing the appropriation and expenditure of an amount not to exceed \$80,000 from the Capital Improvement Fund for the implementation; authorizing the expenditure of an amount not to exceed \$40,000 annually for up to five years for licensing; waiving the formal competitive procurement requirements of TMC Chapter 187; and declaring an emergency.

Body: SUMMARY & BACKGROUND:

The city is in need of a software solution to create a secure environment for the collection and integration of sensitive vendor information within the financial system. Currently, banking information and other personal identifying information (PII) is gathered through email and paper forms, which have to be manually entered by city staff into the financial system. In order to achieve the desired level of security and streamline the vendor registration process, the Finance Department requests to procure a software solution that will directly interface with the city's SAP-ERP system.

This ordinance also requests the waiver of formal competitive bidding requirements of TMC Chapter 187. The Finance Department has begun the process of soliciting informal bids for this project. The waiver would allow the city to expedite the implementation of the vendor portal as soon as possible.

The Toledo Celtics Soccer Club submitted a District Improvement Program application for the Schneider Park Improvement Project in District 2. The proposal includes the purchase of new soccer goals with safeguards to help prevent major, avoidable accidents and improve the aesthetic of the park, as well as a storage container to place the goals and complex equipment during winter months. The District Improvement Review Committee convened on February 26, 2020, and recommended approval of this application in an amount not to exceed \$19,000.

TMP-4961 Extending a Special Use Permit granted by Ordinance

No. 218-19 for a period of 6 months for a Community Center located at 4100 Harvest Lane, in the City of Toledo, Lucas County, Ohio; subject to certain conditions; and declaring an emergency.

Body: SUMMARY & BACKGROUND:

On April 30, 2019, the Council of the City of Toledo passed Ordinance No. 218-19 granting a Special Use Permit (SUP-1007-19) for a Community Center located at 4100 Harvest Lane, Toledo, Ohio.

Due to delays experienced by the applicant, Christ the King Church, in designing the subject property, the Special Use Permit granted by Ordinance No. 218-19 will expire April 30, 2020 pursuant to T.M.C. §1111.0707 because the use has not been established or maintained. Applicant has requested from City Council a 6-month extension of the Special Use Permit to October 30, 2020 in order to allow additional time so that the project may be completed. Such extension is permitted with Council's approval.

Toledo City Council authorized District Improvement Program application for the installation of eleven (11) decorative light posts on

the north side of Sylvania Avenue between Douglas and Secor. It has been determined that extending this project to Jackman Road will benefit the neighborhood and help to bolster the vitality of the business district. Additional funding is available in the Capital Improvement Fund for Lighting Projects.

Bernadine Tammarine-Martin filed a claim for her injuries as a result of stepping into a small hole near a damaged and unrepaired sewer inlet on May 10, 2016. Ms. Tammarine-Martin's injuries required several months of rehabilitation, and will likely require an ankle fusion surgery.

A proposed agreement has been reached in the amount of \$15,000.00 to settle all of Ms. Tammarine-Martin's alleged negligence claims resulting from the incident.

A proposed agreement has been reached in the amount of \$14,500 to settle all claims resulting from this incident without constituting an admission of liability for any violation of state or federal law.

Authorizing the mayor to enter into and execute cooperative agreements between the City of Toledo and the Metropolitan Park District of the Toledo Area and to give consent to the Metropolitan Park District of the Toledo Area for construction of a bike path on Byrne Road from the bridge over Swan Creek to Arlington Avenue within the city limits; and declaring an emergency.

Body: SUMMARY & BACKGROUND:

The Metropolitan Park District of the Toledo Area (Toledo Metroparks) will be constructing a bike path within Swan Creek Park that ends at the city right of way at Byrne Road. This is part of the Swan Creek Trail that is in the City's adopted 2015 Bike Plan. The trail is supposed to continue and connect to the already constructed portion along Arlington Avenue. The connection piece between the two sections would be an approximately 500' bike path along Byrne Road. The city has worked with the Metroparks to have them include in their plans the design and construction of the Byrne Road section that is within the City of Toledo Limits. This project is scheduled to construct in 2020.

The Metropolitan Park District of the Toledo Area will administer the design and construction of the project with Metroparks' funding and is paying for 100% of the construction outside of the city limits. The City of Toledo will participate in the costs by paying for 100% of the portion that is within the city limits, to be paid for with Matches and Planning funds.
