Body:

SUMMARY & BACKGROUND:

The purpose of this ordinance is to facilitate the installation of 147 banners along high traffic, major corridors in the city of Toledo in time

for the Fourth of July, Jeep Fest 2021, and Solheim Cup 2021. The banners will be hung on City-owned poles in the medians of Reynolds Road, between I-90 & Brownstone Boulevard, and Dorr Street, between Lawrence Ave & Forest Ave, as well as on light posts owned by First Energy, along both sides of the street, on St. Clair Street, between Jefferson Avenue & Adams Street, Huron Street, between Monroe Street & Adams Street, and Summit Street, between Jackson Street & Lafayette Street.

The total cost of the project is estimated to be \$35,000, with the City contributing \$21,000 of this total to cover the costs of hardware and installation. Funds will be paid to CGS imaging. The remainder of the funds needed for this project will come from sponsors.

The 2021 Solheim Cup is expected to bring up to 150,000 visitors to the city of Toledo, draw 7.3 million television viewers, and over one billion social media impressions. The Solheim Cup Opening Ceremonies are expected to bring over 30,000 visitors downtown. The projected economic impact that the 2021 Solheim Cup is expected to have on our region is \$32 million. Jeep Fest is expected to draw 60,000 people downtown and have an economic impact of \$5.6 million. This project will facilitate the city and community putting its best foot forward to maximize the economic impact of these events, and to encourage similar events and investment in the city of Toledo moving forward.

SUMMARY & BACKGROUND:

The American Rescue Plan Act of 2021 was signed into law on March 11, 2021. As part of this COVID-19 stimulus package, federal funding will distributed to state and local governments to address the continued impact of COVID-19. The City of Toledo is projected to receive approximately \$188.7 million through the ARPA. Half of this funding is expected in May of 2021 and half is expected in 2022. Funding must be spent by the end of calendar year 2024.

This ordinance authorizes the establishment of the Local Fiscal Recovery Fund to account for the award of these funds. The Ohio Auditor of State issued Bulletin 2021-004 (attached for reference) to provide accounting guidance for the ARPA programs and to emphasize the need for separate accountability of these federal funds.

This ordinance further authorizes the Mayor to accept and deposit ARPA funds into the Local Fiscal Recovery Fund. Subsequent ordinances will be presented to authorize appropriation and expenditure of funds for activities eligible under the ARPA.

Engineering Services owned two Trimble R8 Global Network Satellite Systems, both purchased in 2005. One unit was replaced in 2020, the second unit can no longer be repaired and has been deemed obsolete by the manufacture. The Trimble R12 has the ability to track three times the satellites as the current survey system along with the ability to connect to satellites in dense and wooded areas, which will allow surveys to be completed expediently, and with more accuracy. This system is available through Precision Laser and Instrument, Inc., which is a proprietary seller of Trimble products in the Toledo area. The Bay View Park Water Reclamation Plant is an activated sludge plant that serves the City of Toledo and surrounding communities, and operates continuously. Many of the plant facilities are over 30 years of age and are beyond the intended service life. The Plant Wide Facilities Plan is a study which will address the entire plant treatment system and collection system and develop a facilities plan to renovate, update, and replace the existing systems as necessary to provide continued service.

The Division of Water Reclamation has advertised for and received proposals for professional engineering services for this purpose. The Division seeks to utilize funds from the Sewer Replacement Fund, and to further appropriate and expend such funds on the Plant Wide Facilities Plan.

Every year, the Division of Streets, Bridges & Harbor (SBH) includes in its annual CIP fund request a line item for Matches and Planning. The above mentioned amount is remaining in the 2019 CIP appropriation to SBH that has not yet been expended. The reason for the delay in expenditure has to do with two delays in major bridge projects; Marengo and Secor over Ottawa. Marengo has since resumed construction and will be complete later this year and is now fully funded. Secor over Ottawa has received an additional grant and is sufficiently funded. That makes the remaining \$292,641.43 available for the completion of the Downtown Seawall Project (approximately \$200,000 needed), completion of Levee Improvements (approximately \$50,000 needed), as well as to plan for future projects such as Kuhlman Drive over NSRR. It is imperative that the Division of Streets, Bridges & Harbor's Matches and Planning Program be authorized immediately as there are strict deadlines for planning, design, environmental, bid, and construction associated with each grant fund source.
