Safety

- * Fills a void in the TMC with an aspirational, forward-thinking goal to realize the true value of youth programming, sports participation and providing a safe and positive environment for young people and their families.
- * Verifies confirmation in public law that the safety of Toledo's youth matters, especially while participating in programming in COT parks and facilities.
- * Affirms the commitment to the care, protection and proactive stance of City government toward the municipality's young people; and is a positive legislative response to results of a 2021 community survey listing safety as a community priority.

Requirements

Who:

Applies to organizations and entities receiving city funding and requesting a permit to utilize City parks or facilities for Youth Programs

Exempted: Privately funded youth sports organizations and other organizations providing youth programming in existence prior to December 31, 2021.

What:

Provide proof of having met through any practical, verifiable means or appropriate affiliation, compliance with the applicable safety requirements described in this ordinance.

- Unsupervised Access To A Child
- * Certify that persons 18 or older with unsupervised access to a child of whom they are not the parent or guardian has completed a criminal records check done pursuant to standards established by Ohio Revised Code Sections 109.574 through 109.577.

"The Two Person Rule"

- It's The Holy Grail Of Student Access the thing earnestly pursued or sought after during time adult volunteers who work with children on a regular basis, seek.
- No criminal records checks required.
- Tells the Department of Parks and Youth Services that this Is the standard the organization uses with respect to supervised child access by adults who are working with children that are not their own.
