SMART Analysis Element	Program or Project Analysis and Explanation
Sustainable	TPD is currently using Shot Spotter in two other areas of the City of Toledo to address gun crime and improve the quality of life in the covered areas. The other areas are funded through grants and capital improvement fund. Provided it is as effective as expected we plan to seek additional funding beyond the 3 years. Funds will be sought through grant applications and/or other public/private partners in the community. There is currently one public/private grant partnership that funds the West Central Shot Spotter area of Toledo.
Meets Guidelines	Utilizing Shot Spotter falls within the White House / US Treasury guidelines for preventing and responding to violence. Specifically, investing in technology and equipment to allow law enforcement to more efficiently and effectively respond to the rise in gun violence. Additionally, this project falls within the census tracts identified for the ARPA funding. Please see attached US Treasury guidance identifying this eligible use.
Accountable	The Toledo Police Department's Investigative Services Division will be responsible for the implementation, operation and assessment and reporting of this program. Through the Criminal Intelligence Section Shot Spotter alerts and crime statistics will be compiled and analyzed. The Crime Lab will conduct testing and analysis of shell casings and guns recovered.
Return on Investment	This proposed expenditure will provide a much needed resource to combat gun crimes. There is currently no better means to detect gunshots and pinpoint their precise location. This greatly improves response time, apprehension of suspects, rendering of medical aid to victims and recovery of evidence. These efficiencies reduce other costs by acting as a force multiplier. The Investigative Services Division will compile statistics and analyze the effectiveness of this project.
Transparent	The entire \$840,000 requested for this project will be spent for Shot Spotter (SST, Inc.) in East Toledo. The funds will be spent over a three year period. Year 1,2, and 3 will have annual payments of \$280,000.
