#### STAFF ANALYSIS

The applicant is requesting the vacation of an unimproved north-south alley bounded by north of Expressway Drive, just west of Stickney. The applicant requesting the vacation owns Kim's Auto and Truck Service at 3705 Stickney Ave, which abuts this alley, and wishes to use this land for private, gated access to his business. Northern portions of this alley and surrounding roadways have recently been vacated for the new Jeep customization facility, which has just been completed to the west of this site. The only other property abutting the alley is owned by Fiat Chrysler Automobiles (FCA).

# Toledo 20/20 Comprehensive Plan

The Toledo 20/20 Comprehensive Plan designates this area as Fort Industry, and recommends designating several large parcels of land as future business or industrial parks, and aggressively utilizing and marketing brownfields. As a result of successful land consolidation and marketing efforts since the adoption of this plan, the small residential parcels which were served by this alley have been reutilized for industrial use, and the alley is no longer needed. The proposed use of the vacated alley conforms to the recommendations of the Toledo 20/20 Comprehensive Plan.

### PLAN COMMISSION RECOMMENDATION

The Toledo City Plan Commission recommends approval of V-86-22, the request for the Vacation of North-South alley adjacent to lots 27-31 in the Northlawn Addition, to Toledo City Council for the following reason:

1. The proposed Vacation conforms to the Toledo 20/20 Comprehensive Plan (TMC§1111.0606(A) – Review & Decision-Making Criteria).

The conditions of approval are as follows and listed by agency of origin. Applicants are encouraged to contact each of the agencies to address compliance with their conditions.

# Division of Engineering Services

1. Sewer in alley serves the business on the corner. If vacated, the sewer will become private and the responsibility of the owner to maintain.

#### Plan Commission

2. A Site Plan Review shall be required for any future developments within the vacated area in accordance with the provisions of the Toledo Municipal Code.




