STAFF ANALYSIS

The applicant is requesting the Vacation of all Rights-of-Ways located at the terminus of Marina Drive, between Front Street, the Craig Street Bridge and the Maumee River. The area to be vacated includes both Front Street Right-of-Way and ODOT excess lands. The applicant, Metroparks Toledo, owns the adjacent property. Surrounding land uses include the Glass City Metropark, the National Museum of the Great Lakes, and a marina to the north; Tribute Park, a car wash, and a gas station to the south; the Craig Street Bridge and I-280 to the east; and the Glass City Metropark, the National Museum of the Great Lakes, and a marina to the west. On 08/17/2022, City Council approved a declaration of intent (*Res. 187-22*) to Vacate the requested portion of ODOT lands and Front Street.

STAFF ANALYSIS

The applicant, Metroparks Toledo, is requesting the Vacation in order to facilitate the expansion of the Glass City Metropark. The previously approved Special Use Permit for Phase II of the Glass City Metropark (SUP-2006-21), proposed the ODOT excess lands to the north be for urban camping, and the Right-of-Way along Front Street to be for trees and a multiuse path. The area requesting to be vacated was previously targeted for I-280 ramps, however since the Veterans Glass City Bridge was constructed, the roadways in this location have been reconfigured from the initial plans and the right-of-way is no longer necessary to serve the infrastructure. On 04/12/2022, City Council approved a declaration of intent (*Res. 187-22*) to Vacate the requested portion of Front Street.

Connecting the Pieces Plan

The 2008 Connecting the Pieces Plan identifies the area being vacated as the location for a natural area and a trail to connect to proposed parks. The trail was constructed along with the Veterans Glass City Bridge project, and serves as bicycle and pedestrian access along Front Street. The trail will remain with the proposed Glass City Metropark, and further fulfill the Connecting the Pieces Plan vision of building vibrant public spaces in East Toledo.

Toledo 20/20 Comprehensive Plan

The Toledo 20/20 Comprehensive Plan future land use designation targets the proposed adjacent land as Urban Village. This land use category is a specialized residential and commercial district that possesses characteristics of Traditional Neighborhood Development (TND), such as pedestrian orientation, zero building setbacks, mixed uses, and district architectural character. The proposed Vacation areas will be added to Glass City Metropark, and will be a valuable public amenity.

Staff recommends approval of the proposed Vacation as it will not impede or restrict access to any adjoining property owners abutting the site. Additionally, the request conforms to the goals of the Connecting the Pieces Plan.

PLAN COMMISSION RECOMMENDATION

The Toledo City Plan Commission recommends approval of V-187-22, the request for the Vacation of excess former ODOT right-of-way, located at Front Street & the Craig Bridge to Toledo City Council for the following two (2) reasons:

1. The proposed Vacation will not impede or restrict access to any property owners abutting the site; and,

2. The proposed Vacation conforms to the Toledo 20/20 Comprehensive Plan and the 2008 Connecting the Pieces Plan (TMC§1111.0606(A) – *Review & Decision-Making Criteria*).

The Toledo City Plan Commission further recommends approval of V-187-22, the request for the Vacation of all Right-of-Ways located at the terminus of Marina Drive, between Front Street, the Craig Street Bridge and the Maumee River to Toledo City Council subject to the following **five (5)** conditions:

The conditions of approval are as follows and listed by agency of origin. Applicants are encouraged to contact each of the agencies to address compliance with their conditions.

Division of Engineering Services

1. A 72-Inch public water main crosses two of the three parcels. An easement shall be provided.
2. Ordinance shall note that an easement for a public storm and sanitary sewer is provided across the entire vacation (if not specified in detail between now and then and approved as to content of detail).

Toledo Area Regional Transit Authority

3. TARTA has a bus stop located Southeast of the Front St Marina at the 20' strip vacation highlighted in the reference map.

The location has continuous sidewalk which connects to the nearby walking path. This spot is important for access to the transit system from nearby neighborhoods and destinations. As such, TARTA intends to maintain this as a bus stop.

TARTA requests to be consulted on changes to that location to ensure reasonable accommodations can be made for transit customers. TARTA can approve the vacation as long as transit access can be maintained.

Division of Transportation

4. Within the limits allowed by law, the applicant shall indemnify the City of Toledo, its officials, agents or employees, from any and all claims, demands, causes of action, suits or liability in connection with the performance of any and all acts authorized or permitted under this vacation. Said indemnification language shall be contained within and evidenced by the endorsement on a certified copy of the final vacating legislation by the owner which indemnification shall be kept in the permanent file of the Clerk of Council.

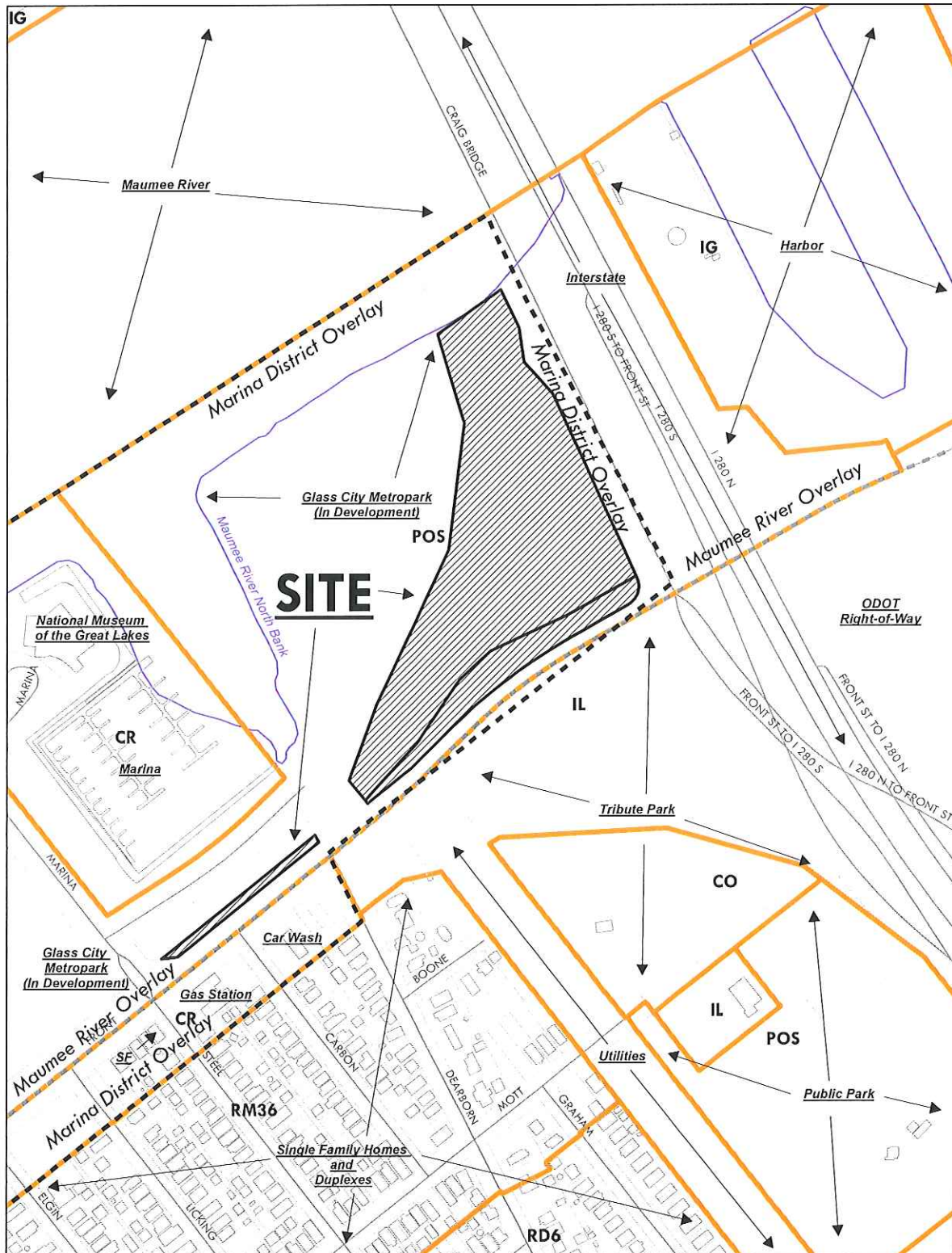

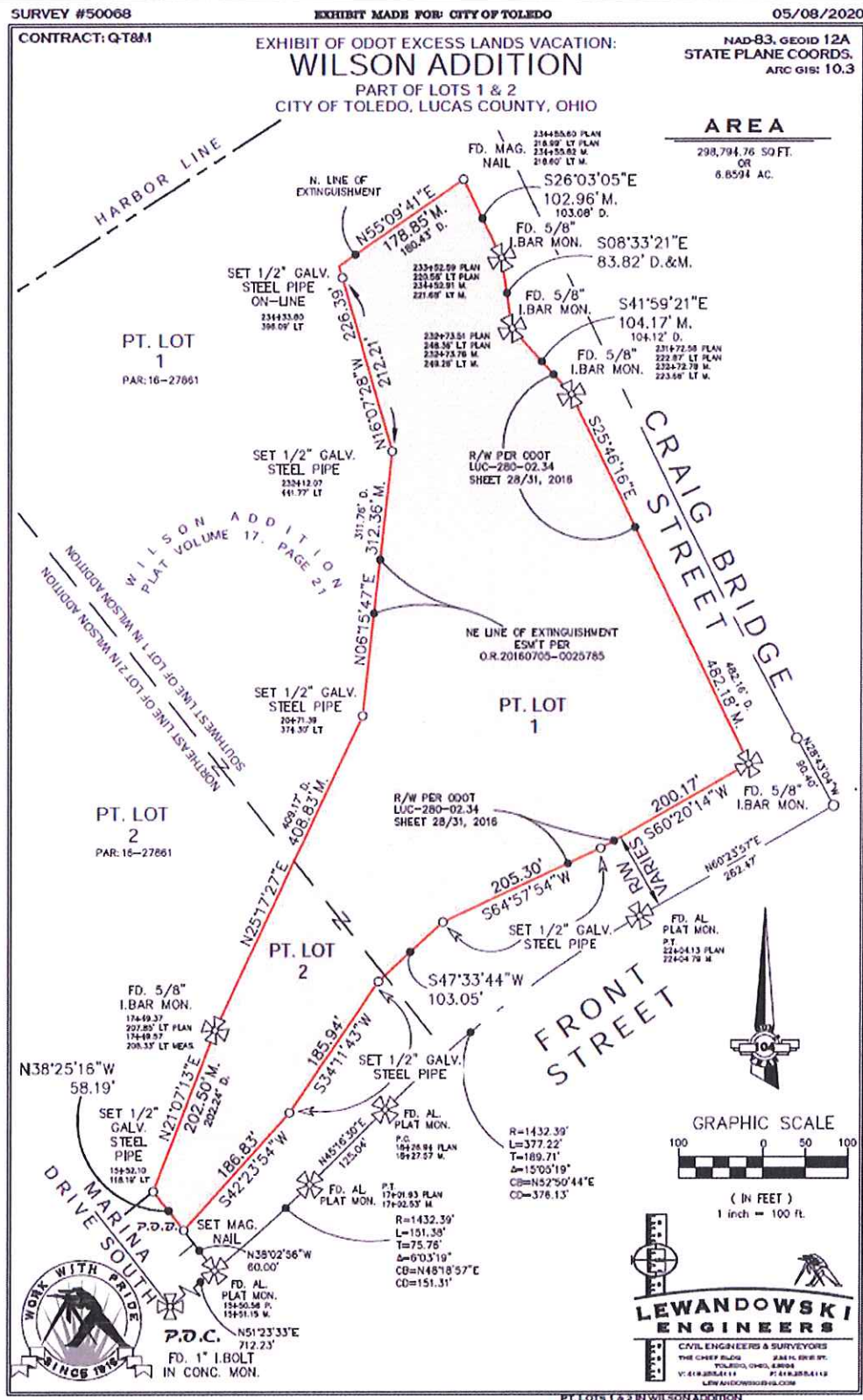
ZONING & LAND USE

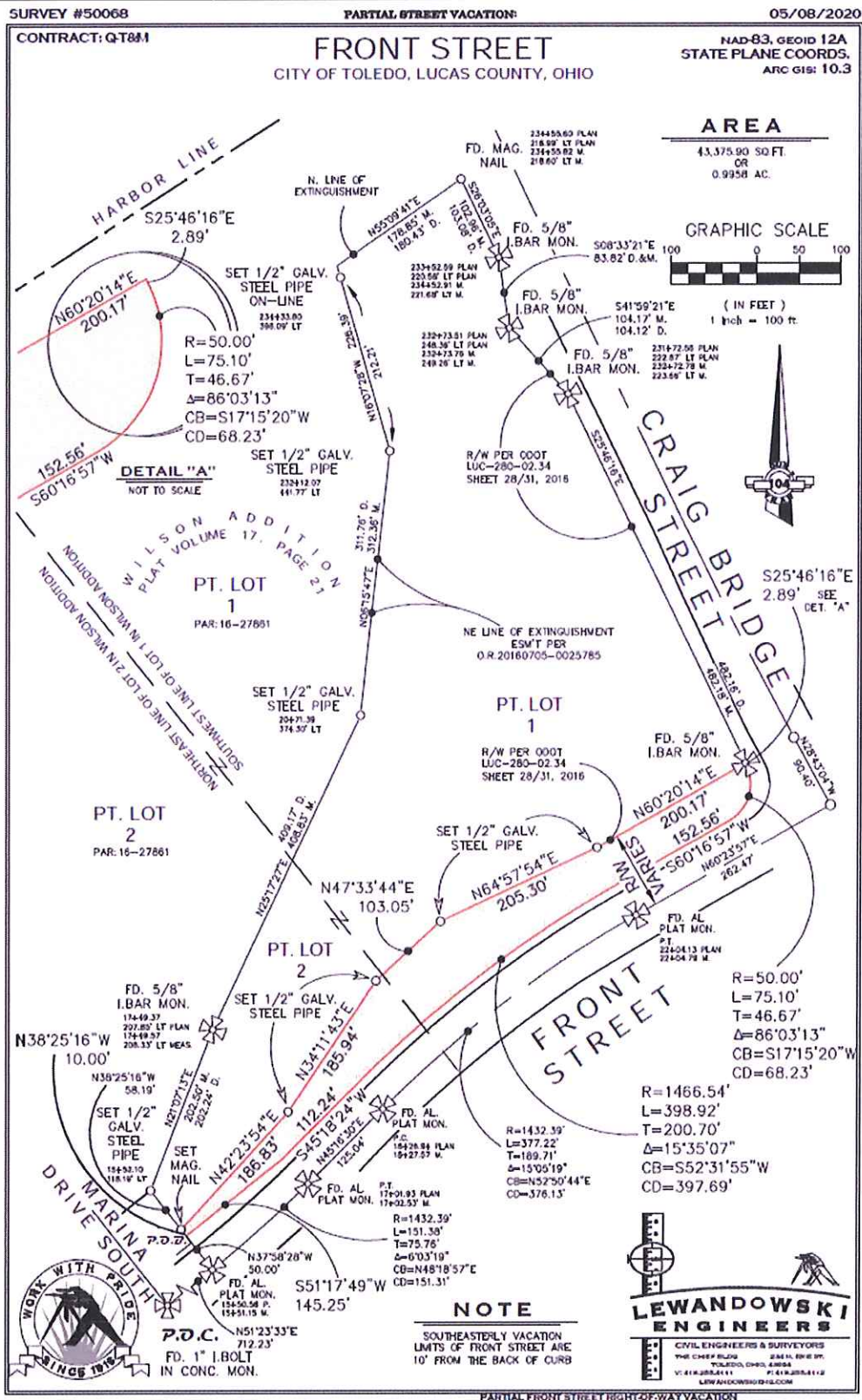

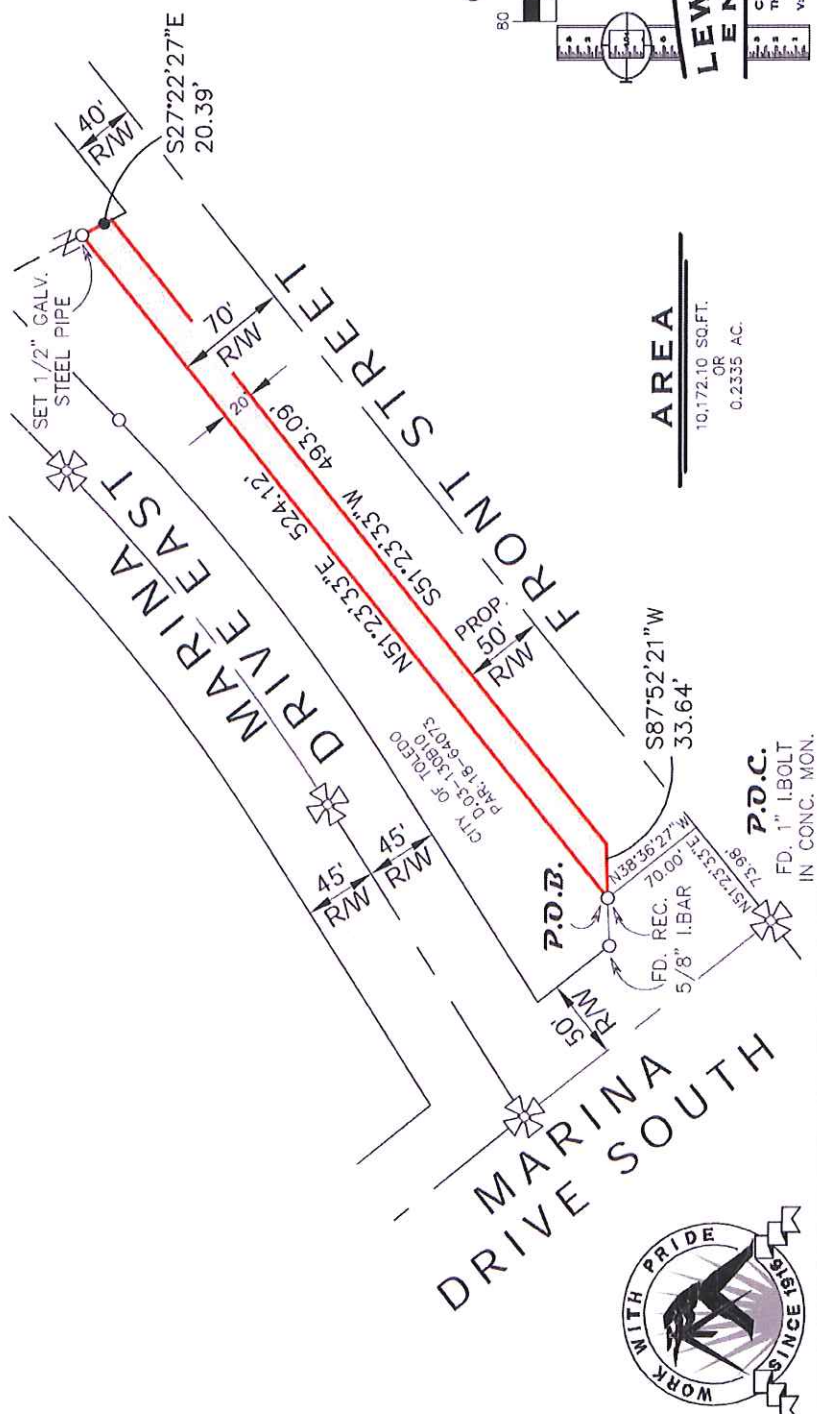
