2022 Tax Incentive Review Meeting (TIRC) September 29, 2022

Ryan Reiter proctored the City of Toledo TIRC meeting which began at: 1:35

The review of City Enterprise Zones (EZ), Community Reinvestment Areas (CRA), and Tax Increment Financing (TIF) projects is to be overseen by at least one person from the Auditor's office, three people from the City of Toledo, and one person from the Treasurer's office.

Introductions were made and roll call was taken.

Toledo Public Schools sent the Lucas County Auditor an email correspondence about their recommendation to terminate the St Hedwig Senior Housing LLC Tax abatement.

Washington Local Schools sent the Lucas County Auditor and email correspondence about their recommendation to terminate the Holland Hospitality AKA Benore Lodge, LLC abatement

City CRAs:

Jeff Fouke motioned to terminate Holland Hospitality AKA Benore Lodge, LLC due to lack of payment and response to multiple good faith communications. The transfer of ownership issue further spurred action on part of Washington Local.

Mark Austin seconded the motion, with unanimous support from those in attendance.

The next step is to provide Toledo City Council a request to terminate, of which they have 60 days to respond. City of Toledo and the Auditor are both researching whether or not an official ordinance is required to approve the termination.

Paul Overman motioned to terminate St Hedwig Senior Housing, LLC due to the same reasons. Brandon Selhorst seconded, with unanimous support from those in attendance.

Ryan Reiter motioned to approve all other CRAs. Paul seconded. Motion approved.

City of Toledo asked about both the Overland and downtown district TIFs. There has been an on-going conversation with the State of Ohio about what is holding up the process. Curtis Deeter shared the State's explanation, which revolves around a large number of parcels (downtown district) and prior exemptions. It was recommended that the City follow up with the State of Ohio.

Ryan Reiter motioned to approve all TIFs. Brandon Selhorst seconded. Motion approved.
