Undergraduate and graduate school was paid for through grants, loans, scholarships and working odd jobs such as bar tender, kitchen help, office temp work, secretary, and teacher. Additionally, I have many years experience teaching music in the public schools (New York and California), and have always had a private studio offering private trumpet lessons to children and adults. Students with economic hardships have often been taught for free.

My mother remarried an African American; I have step brothers and a sister and although we did not grow up together I feel very close to them. I have been a member of the LGBT community for many years, and have seen the destructive nature of prejudice, anger, and misunderstanding. I have also seen the positive changes slowly becoming part of our ethos.

My personal struggles in life were some of the same issues many in our community face and I feel I can offer great insight, knowledge, and compassion to better serve Toledo.

The Human Relations Board is a necessary and exciting conduit for positive change in Toledo. One of Toledo's great attributes is the incredible diversity in it's population and I believe Toledo can be a bench mark for the nation in its successes in bringing people together and bettering the future of its community.
