Board of Building Appeals

Reference:

TMC Chapter 1315

Ordinance No. 127-15

Purpose: The City of Toledo Board of Building Appeals is certified with the State of Ohio through the provisions of the State's Board of Building Standards. The Board of Building Appeals shall hear and decide appeals from within the jurisdiction of orders, decisions, or determinations made by the Chief Building Official relative to the application of the Ohio Building Code, the Residential Code of Ohio, and Part Thirteen - Building Code.

Appointment: Mayor

Members: 5

Term Length: 5 years

Makeup:

- One attorney at law, admitted to the Ohio bar;
- · One architect, registered in Ohio;
- One structural engineer, registered in Ohio;
- One mechanical engineer, registered in Ohio;
- One member representing organized labor who is knowledgeable in the construction and equipment of buildings and structures.

All members shall reside in the metropolitan Toledo Area.

Terms: The term of a member of the Board of Building Appeals is five (5) years. Upon the expiration of the term of a member of the Board of Building Appeals, his successor shall be appointed for a term of five years by the Mayor.

A member shall hold office from the date of appointment until the end of the appointed term; however, the member shall continue in office following the term expiration date until a successor takes office or until sixty days have elapsed, whichever occurs first.

Vacancies: Any member appointed to fill a vacancy occurring before the expiration of a term shall hold office for the remainder of the term

Three members of the Board qualified to vote shall constitute a quorum. No Board member shall act in any case in which he or she has personal interest.

Meetings: Meetings shall be called by the Chairman of the Board, at the request of any member, by the Chief Building Official, or by the Commissioner of Building Inspection. Any Board member who misses more than three consecutive meetings shall become ineligible to continue on such Board and shall be automatically removed. His or her replacement shall be appointed by the Mayor for the unexpired term.
