Beginning at a ¾ inch pin found in an existing monument box marking the Southwest corner of said Section 8, Southwest corner of said City of Toledo parcel and being a point of intersection for the said centerline of right of way of Byrne Road (Station 131+54.54 Byrne Road);

Thence North 00 Degrees 20 Minutes 51 Seconds East a distance of 279.00 feet with the West line of said Section 8, said centerline of right of way of Byrne Road and Westerly line of said City of Toledo parcel, to a ¾ inch pin found in an existing monument box marking the Intersection of the centerline of right of way of Byrne Road with the centerline of right of way of State Route 2, said point being the Northwest corner of said City of Toledo parcel (Station 134+33.54 Byrne Road and Station 728+15.21 SR 2);

Said coordinates originated from GPS observations of selected stations in the Ohio Department of Transportation Virtual Reference Station Network. The portion of the centerline of Byrne Road having a bearing of North 00 Degrees 25 Minutes 42 Seconds East is designated the Basis of Bearing for this description.
