Authorizing the disappropriation of \$2,000,000 from the Water Bond Improvement Fund; authorizing the appropriation and expenditure of \$2,000,000 in the Water Bond Improvement Fund for the Raw Water Mains Upgrade Project; authorizing the mayor to accept bids and execute contract(s) for the design, preparation of plans and specifications, engineering, bidding, construction oversight, testing, permits, renovation, construction, appurtenances, and other related work, tasks, equipment, and materials needed; and declaring an emergency.

SUMMARY & BACKGROUND:

Ordinances 211-13 and 475-16 previously authorized funding for renovation and improvement of the low service pump station and raw water mains. This ordinance authorizes additional funding that will enable the service life of the existing mains to be extended another 30 years or more. To provide additional funds, this ordinance authorizes reappropriating monies remaining from projects funded from the Series 2013 Bond Issuance.

NOW, THEREFORE, Be it ordained by the Council of the City of Toledo:

SECTION 1. That the following project in the Water Bond Improvement Fund is reduced of encumbrances and disappropriated:

SECTION 2. That an amount not to exceed \$2,000,000 is appropriated from the unappropriated bond proceeds of the Water Bond Improvement Fund in account code 6062-32000-4UB1713STDSTD (Raw Water Mains Upgrade); and the expenditure of same is authorized for the Raw Water Mains Upgrade Project.

SECTION 3. That the mayor is authorized to accept bids and execute contract(s) for design, preparation of plans and specifications, engineering, bidding, construction, testing, permits, and other related work, tasks, equipment and materials needed for the Raw Water Mains Upgrade project upon such terms and conditions shall be approved by the Director of Public Utilities and the Director of Law.

SECTION 4. That the Finance Director is authorized to issue his warrant or warrants against the account code identified in Section 2 in an amount not to exceed \$2,000,000 in payment of the obligations incurred pursuant to the contract(s) authorized in Section 3 upon presentation of the proper voucher or vouchers.

SECTION 5. That the disappropriation of any remaining budget to fund balance is authorized at project closeout.
