Authorizing the mayor to accept a donation of 125 cases of Med X universal disposable protective aprons from The Ohio State University for the City of Toledo, Department of Fire & Rescue Operations; and declaring an emergency

SUMMARY & BACKGROUND:

The City of Toledo Fire and Rescue Department has received a donation of 125 cases of Med X universal disposable protective aprons to be used during emergency medical responses to contain patient bodily particulates from contaminated patients.

NOW, THEREFORE, Be it ordained by the Council of the City of Toledo:

SECTION 1. That the mayor is authorized to accept the donation of 125 Cases of Med X universal disposable protective aprons from The Ohio State University with a total market value of \$50,000.

SECTION 2. That the mayor is authorized to execute any necessary agreements for the provision of 125 cases of Med X universal disposable protective aprons to be used by the Department of Fire and Rescue Operations during emergency medical responses to contain patient bodily particulates from contaminated patients.

SECTION 3. That this Ordinance is declared to be an emergency measure and shall take effect and be in force from and after its passage. The reason for the emergency lies in the fact that this Ordinance is necessary for the immediate preservation of the public health, safety and immediate use of the donated equipment.
