### **Officially renaming Superior Park located at 1221 North Superior Street, Toledo, OH 43604, to "Paul William Alexander Park"; and declaring an emergency.**

#### SUMMARY & BACKGROUND:

The YMCA of Greater Toledo approached the city with a request to identify a landmark that could be named after Toledoan Paul William Alexander, the founder of the Y's Men International (YMI). The YMI is recognized globally as a service organization promoting cultural awareness leading to brotherhood and world peace. Superior Park was chosen for the renaming because it is in close proximity to the home where Mr. Alexander was raised.

NOW, THEREFORE, Be it ordained by the Council of the City of Toledo:

SECTION 1. That the City Council does declare Superior Park located at 1221 North Superior Street in the City of Toledo, Lucas County, Ohio, be designated and named Paul William Alexander Park.

SECTION 2. That the proper City officials are authorized to execute such instruments, documents and certifications and to take such other actions that may be necessary or appropriate in connection with the full implementation of Section 1.

SECTION 3. That the Division of Transportation is authorized to approve the appropriate signs reflecting the naming of “Paul William Alexander Park”.

SECTION 4. That this Ordinance is declared to be an emergency measure and shall be in force and effect from and after its passage. The reason for the emergency lies in the fact that same is necessary for the immediate preservation of the public peace, health, safety, and property and for the further reason that this Ordinance must be immediately effective in order to allow for the expeditious and early implementation of the provisions of this ordinance.
