OCJS Body Worn Cameras \$62,400

Authorizing the Mayor to enter into a grant agreement and accept and deposit \$62,400 from the Office of Criminal Justice Services for an Ohio Body-Worn Camera Grant (2024-BW-LEC-3060) Program; authorizing the appropriation and expenditure of an amount not to exceed \$62,400 from the unappropriated balance of the Operation Grants Fund; authorizing the mayor to enter into an agreement with Getac Video Solutions, Inc. for the purchase of body worn cameras; waiving the competitive bid requirements of Chapter 187 of the Toledo Municipal Code; and declaring an emergency.

SUMMARY & BACKGROUND:

The Toledo Police Department has requested and received \$62,400 in Ohio Body-Worn Camera Grant funds from the Ohio Office of Criminal Justice Services. There is no local match required for this grant. The grant funds will be used to purchase body worn cameras. Getac Video Solutions Inc. is the Toledo Police Department's current supplier for body worn cameras. We are waiving competitive bidding since no other cameras would be compatible with our current Getac Video Solutions, Inc. system.

NOW THEREFORE Be it ordained by the Council of the City of Toledo:

SECTION 1. That the Mayor is authorized to enter into a grant agreement and accept and deposit the amount of \$62,400.00 from the Ohio Office of Criminal Justice Services from the Ohio Body-Worn Camera Grant into the Operation Grants Fund.

SECTION 2. That the appropriation of \$62,400.00 is authorized from the unappropriated grant proceeds of the Operation Grants Fund to Account Code 2016-52000-3G00087STDSTD and the expenditure of same is authorized to purchase body worn cameras from Getac Video Solutions, Inc.

SECTION 3. That this council finds it in the best interest of the city to waive the competitive bidding requirements of TMC Chapter 187 for the reason that Getac Video Solutions, Inc., is the sole source provider for Getac body cameras and is the current provider of body cameras for the Toledo Police Department. Any other body cameras would not be compatible with our current system.

SECTION 4. That the Finance Director is authorized to draw a warrant or warrants against the above mentioned Account Code in an amount not to exceed \$62,400.00 in payment of the obligations authorized above by the terms of the grant upon presentation of the proper voucher or vouchers.

SECTION 5. This Ordinance is declared to be an emergency measure and shall be in force and effect from and after its passage. The reason for the emergency lies in the fact that it is necessary for the immediate preservation of the public peace, health, safety, and property, and to expedite the receipt and expenditure of grant funding.
