### **Declaring the intent to vacate a portion of the 20-foot alley and all of a 16-foot alley surrounded by Lagrange, Moore and Elton Street, City of Toledo, Lucas County, Ohio; and declaring an emergency.**

#### **SUMMARY & BACKGROUND:**

Petitioner has filed a request to vacate the alley adjacent to the Bavarian Sports Club located at 2102 Lagrange Street, in City of Toledo, Lucas County, Ohio.

NOW, THEREFORE, Be it resolved by the Council of the City of Toledo:

SECTION 1. That the City Council does hereby declare its intent to vacate the alley further described below:

Vacating the 20-foot alley and all of a 16-foot alley surrounded by Lagrange, Moore and Elton Street.

Being all of a 20-foot wide alley located between Lots 5 thru 8 together with a portion of a 16-foot wide alley lying northwesterly of Lots 10 and 11 all within the Plat of Sumner's Subdivision of Part of Osborne Place, recorded on November 15 1890 in Plat Volume 13 on page 38

SECTION 2. That this matter be referred to the Toledo City Plan Commission for its review, recommendation and appropriate hearing date.

SECTION 3. That this Resolution hereby is declared to be an emergency measure and shall be in force and effect from and after its adoption. The reason for the emergency lies in the fact that same is necessary for

the immediate preservation of the public peace, health, safety and property, and for the further reason that this Resolution must be immediately effective so that the vacation can be expeditiously completed to enable property owners to obtain the resulting benefits at the earliest time.
