NOW, THEREFORE, Be it resolved by the Council of the City of Toledo:

SECTION 1. That the City Council does hereby declare its intent to vacate the 12-foot-wide alley running North to South and lying adjacent to Lot 12 for a distance of 35 feet in the A.J.Brown Addition, located in the city of Toledo, Lucas County, Ohio, further described below:
