Authorizing the expenditure of up to \$25,000 for a Vault Lowering Device at Forest Cemetery; authorizing the mayor to accept bids and award contracts; and declaring an emergency.

SUMMARY & BACKGROUND:

This Ordinance authorizes expending up to \$25,000 to purchase a vault lowering device. This purchase has been deemed a necessity by the safety and training staff from the Department of Public Service, as a protection for our workers against the possibility of severe injury. Vault handlers have become the industry standard nationwide for cemetery operations.

The fiscal impact of this ordinance is as follows:

NOW, THEREFORE, Be it ordained by the Council of the City of Toledo:

SECTION 1. That the amount of up to \$25,000 is authorized from expenditure from Account Code 5040-60500-8CP1922VLTHST for the purchase of a vault lowering device.

SECTION 2. That the Mayor is authorized to accept bids and award contracts for the purposes specified in Section 1.

SECTION 3. That the Finance Director is authorized to draw warrant or warrants against the account code in Section 1 in an amount not to exceed \$25,000, in payment of the above authorized obligations upon presentation of the proper voucher or vouchers.

SECTION 4. That this Ordinance, being an emergency measure, shall take effect and be in force from and after its passage. The reason for the emergency lies in the fact that the Ordinance is necessary for the immediate preservations of the public peach, health, safety, and property and to allow prompt acquisition of necessary equipment to preserve employee safety.

Vote on emergency clause: yeas 12, nays 0.

Passed: October 1, 2019, as an emergency measure: yeas 12, nays 0.
