Authorizing the mayor to enter into a 24 month lease agreement with Owens Community College for office and classroom space located on the Owens Community College Main (Perrysburg) Campus for the purpose of training TFRD personnel; authorizing the expenditure of a sum not to exceed \$6,806.33 monthly from the General Fund; waiving the competitive bidding requirements of TMC 187.24; and declaring an emergency.

SUMMARY & BACKGROUND:

Toledo Fire and Rescue Department has negotiated a lease agreement with Owens Community College to include the use of classroom and office space to provide administrative support, academy simulation skills training, educational testing, and state certification completion for TFRD personnel.

The lease agreement defines 5,834 Sq foot of space usage and provides to pay the amount not to exceed \$6,806.33 monthly for the term of the agreement. The term of this agreement will be for 24 months effective January 1, 2021 through December 31, 2022. Total expenditure amounts to \$163,351.92

NOW, THEREFORE, Be it ordained by the Council of the City of Toledo:

SECTION 1. That the mayor is authorized to enter into a lease agreement for office and classroom space for a period of 24 months with Owens Community College for the provision of academy simulation skills training, educational testing and state certification completion for TFRD personnel . Said agreement shall contain additional terms and conditions as deemed proper and requisite according to the mayor, the Director of Fire and Rescue Operations, and the Director of Law. (See attached lease agreement)

SECTION 2. That, subject to available appropriation in future years, an expenditure in an amount not to exceed \$6,806.33 monthly for a period of 24 months is authorized from the General Fund, Account Code 1001-53000-533100-3341002STDSTD for the purpose identified in Section 1.

SECTION 3. That this Council finds it in the best interest of the city to waive the competitive bidding requirements of TMC section 187 for the reason that Owens Community College is the only facility in the Northwest Ohio area that can accommodate both the training facility and equipment needs of the Department of Fire and Rescue Operations.

SECTION 4. That the Finance Director is authorized to draw his warrant or warrants against the above referenced account code in an amount not to exceed \$6,806.33 monthly in payment of the above obligations upon presentation of proper voucher or vouchers.

SECTION 5. That this Ordinance is declared to be an emergency measure and shall take effect and be in force immediately from and after its passage. The reason for the emergency lies in the fact that this ordinance is necessary for the immediate preservation of the public peace, health, safety, and property, and for the further reason that the ordinance must be immediately effective in order that Toledo Fire and Rescue's emergency medical technicians are properly trained and certified.
