Authorizing the Mayor to enter into and execute a cooperative agreement between the City of Toledo and Lucas County and to give consent to Lucas County for watermain improvements on Nebraska from Pine Ridge to Hidden Village Lane; and declaring an emergency.

SUMMARY & BACKGROUND:

Lucas County will be installing a 12-inch watermain on Nebraska between Pine Ridge and Hidden Village Lane in the County to loop the watermains and eliminate two dead ends. The County operates and maintains the water system throughout their service area with the City of Toledo as the operator of record for the water distribution system throughout Lucas County.

Lucas County will administer the design and construction of the project with County funds paying for all of the construction scheduled for 2024.

NOW, THEREFORE, Be it ordained by the Council of the City of Toledo:

SECTION 1. That the Mayor is authorized to enter into and execute cooperative agreements between the City of Toledo and Lucas County for the watermain improvement on Nebraska between Pine Ridge and Hidden Village Lane.

SECTION 2. That the City of Toledo gives consent to and shall cooperate with Lucas County, in connection with the above project, as follows:

- The County agrees to be the lead agency for the construction plans, specifications, design phase, 1. bidding phase, and construction phase of the project.
- 2. The County will obtain any necessary right of way and easements that may be required.
- The County will advertise for bids and administer the construction contract including inspection 3. and testing.
- 4. The County will pay for 100% of any construction or extra work items that are not eligible for State funding.

SECTION 3. That this Ordinance is declared to be an emergency measure and shall be in force and effect from and after its passage. The reason for the emergency lies in the fact that this Ordinance is necessary for the immediate preservation of the public peace, health, safety and property and for the further reason that this Ordinance must be immediately effective in order to permit timely construction for the above project.
