Authorizing the expenditure of \$65,074.20 from the Capital Improvement Fund District Improvement Program for 10 Golf Carts for Bayview Retirees Golf Course; authorizing the Mayor to execute the necessary contract; and declaring an emergency.

## SUMMARY & BACKGROUND:

The officers of the Bayview Retirees Golf Course submitted a District Improvement Program application for the purchase of 10 Tempo electric golf cars. The District Improvement Review Committee convened on May 19, 2023, and recommended approval of this application in an amount of \$65,074.20.

NOW, THEREFORE, Be it ordained by the Council of the City of Toledo:

SECTION 1. That a sum of \$65,074.20 is authorized for expenditure from Account Code 5040-16400-8CP2132DNGPRO for the District Improvement Program, Golf Carts for Bayview Retirees Golf Course.

SECTION 2. That the Mayor is authorized to execute the necessary contract for the District Improvement Program, Golf Carts for Bayview Retirees Golf Course, upon such terms and conditions as shall be approved by the Director of the Department of Economic Development, the Director of Parks & Youth Services, and the Director of Law.

SECTION 3. That the Director of Finance is authorized to draw warrant or warrants against the above account code in payment of the above authorized obligations in an amount not to exceed that authorized in Section 1 upon presentation of the proper voucher or vouchers.

SECTION 4. That this Ordinance is declared to be an emergency measure and shall take effect and be in

force from and after its passage. The reason for the emergency lies in the fact that the same is necessary for the immediate preservation of the public peace, health, safety and property and so that 10 electric golf carts can be purchase for this golf season.
