Authorizing the Hoffman Road Landfill to accept Municipal Solid Waste (MSW) and Construction/Demolition Debris (CDD) generated within Lucas County, Ohio from Klumm Brothers Waste Solutions, LLC (Klumm); authorizing the Mayor to enter into a Disposal Agreement for a period of three (3) years with up to two additional two-year extensions; authorizing the acceptance and deposit of revenues into the General Fund and the Solid Waste Disposal Trust Fund; and declaring an emergency.

SUMMARY & BACKGROUND:

The Department of Public Service, Division of Solid Waste, operates a landfill for receiving Municipal Solid Waste (MSW) and Construction/Demolition Debris (CDD) for the residents of Lucas County. Currently, permitted life expectancy of the landfill is approximately 30 years. Klumm has approached the City of Toledo seeking an Agreement to dispose of residential MSW and CDD collected within Lucas County, Ohio at the Hoffman Road Landfill. The average annual amount of waste to be received over the life of the agreement will be capped at 20,000 tons/year, unless otherwise agreed to in writing by the City. Agreement will be for an initial three (3) year period and provisions for up to two additional two-year contract extensions, all with an annual escalator.

NOW THEREFORE, Be it ordained by the Council of the City of Toledo:

SECTION 1. That the Mayor is authorized to enter into an Agreement with Klumm Brothers Waste Solutions, LLC, for the acceptance of MSW and CDD for a three (3) year period with provisions for up to two additional two-year extensions, upon such terms and conditions as approved by the Director of Public Service and Director of Law.

SECTION 2. That the Mayor is authorized to accept and deposit revenues collected, pursuant to the Agreement referenced in Section 1 to the General Fund Account Code 1001-24500-6232002STDSTD and Solid Waste Trust Fund Account Code 2090-24500-6T23201STDSTD pursuant to City Ordinance No. 621-86.

SECTION 3. That this Ordinance is declared to be an emergency measure and shall take effect and be in force from and after its passage. The reason for the emergency lies in the fact that the same is necessary for the immediate preservation of the public peace, health, safety and property, and for further reason that the Ordinance must be immediately effective in order for the Department of Public Services to enhance revenue for the City of Toledo.
