**Authorizing the expenditure of \$20,000 from the General Fund to support the 2024 Toledo Jeep Fest as a Collaborative Sponsor; authorizing the Mayor to enter into a sponsorship agreement with Toledo Jeep Fest LLC; and declaring an emergency.**

**SUMMARY & BACKGROUND:**

The purpose of this ordinance is to provide funding in 2024 for the 2024 Jeep Fest that is presented by Dana in Downtown Toledo August 1<sup>st</sup> - 4<sup>th</sup>, 2024. This event brings many regional visitors into the area and provides summer fun in the City of Toledo. Other sponsors include Lucas County, UAW, Yark Automotive, The Blade, Keybank, and close to 50 others.

NOW THEREFORE Be it ordained by the Council of the City of Toledo:

SECTION 1. That the expenditure of \$20,000 is authorized from the General Fund Account Code 1001-10202-1143001STDADM for payment to Toledo Jeep Fest LLC for the purpose of being a collaborative sponsor of the 2024 Jeep Fest.

SECTION 2. That the Mayor is authorized to enter into a sponsorship agreement for the purpose authorized in Section 1, upon terms and conditions acceptable to the Director of Law.

SECTION 3. That the Finance Director is authorized to draw warrant or warrants against the above Account Code in an amount not to exceed \$20,000 in payment of the above-authorized obligations upon the proper voucher or vouchers.

SECTION 4. That this Ordinance is declared to be an emergency measure and shall take effect and be in force from and after its passage. The reason for the emergency lies in the fact that this ordinance is necessary for the immediate preservation of the public peace, health, safety and property, and for the further reason that this ordinance must be immediately effective in order to provide timely sponsorship support for the Toledo Jeep Fest that is occurring in 2024.
