**Authorizing the Mayor to enter into an agreement with the University of Toledo to provide paramedic and emergency medical training at UT's Life Support Training Center; waiving TMC 187.24; authorizing the expenditure and payment of a sum not to exceed \$158,500 annually; and declaring an emergency.**

**SUMMARY & BACKGROUND:**

Fire and Rescue Department has negotiated with the University of Toledo for the provision of paramedic and emergency medical training at the UT's Life Support Training Center to include use of classroom and office space, administrative support, simulation skills training and testing and educational delivery and certification. The UT's Life Support Training Center offers better suited facilities for training, testing and certification and advanced educational support. The training agreement is intended to be renewable annually for a 5-year period. This agreement and expenditure is necessary to provide necessary emergency medical and paramedic training and certification.

NOW, THEREFORE, Be it ordained by the Council of the City of Toledo:

SECTION 1. That the Mayor is authorized to enter an agreement with the University of Toledo for the provision of paramedic and emergency medical training, testing and certification at the UT Life Support Training Center under terms and conditions acceptable to the Fire Chief and Law Director. The agreement shall be renewable annually for a period not to exceed five years.

SECTION 2. That the competitive bidding requirements under TMC 187.24 are waived for the reason that this Council finds it is in the best interest of the City to contract with the University of Toledo for the provision of paramedic and emergency medical training, testing and certification at the UT Life Support Training Center due to unique suitable educational facilities.

SECTION 3. That the expenditure of funds in an amount not to exceed \$158,500 annually is authorized for the purpose specified in Section 1 from the General Fund Account Code 1001-53000-3341002STDSTD subject to the appropriation of funds.

SECTION 4. That the Finance Director is authorized to draw his warrant or warrants against the above referenced account code in an amount not to exceed \$158,500 annually in payment of the above obligations upon presentation of proper voucher or vouchers.

SECTION 5. That this Ordinance is declared to be an emergency measure and shall take effect and be in force immediately from and after its passage. The reason for the emergency lies in the fact that this ordinance is necessary for the immediate preservation of the public peace, health, safety, and property, and for the further reason that the ordinance must be immediately effective in order that Toledo Fire and Rescue's emergency medical technicians and paramedics are properly trained and certified.
