Authorizing the settlement of the claims of Green Earth Transportation Services, LLC in Case No. CI-21-1489 pending in the Lucas County Court of Common Pleas for the sum of \$50,000; authorizing the expenditure of \$50,000 from the Risk Management Fund; and declaring an emergency.

SUMMARY & BACKGROUND:

Green Earth Transportation Services, LLC held the City-wide topsoil contracts in 2019-2020. Green Earth alleged the City failed to buy as much topsoil as estimated and brought a lawsuit in Lucas County Common Pleas Court. Following negotiations, an agreement has been reached in the amount of \$50,000 as to all claims without any admission of liability on the part of the City.

NOW, THEREFORE, Be it ordained by the Council of the City of Toledo:

SECTION 1. That the expenditure of \$50,000 is authorized from the Risk Management Fund Account Code 7095-12000-1157001STDSTD in settlement of the claims alleged by Green Earth Transportation Services against the City of Toledo.

SECTION 2. That payment of these claims is contingent upon the execution of a proper settlement and release.
