Changing the zoning maps attached to Part 11, Planning and Zoning, Toledo Municipal Code, for the property located at 1109-1117 Jefferson Ave, 137 N 11<sup>th</sup> Street and 122-132 N 12<sup>th</sup> Street, in the City of Toledo, Lucas County, Ohio; and declaring an emergency.

## SUMMARY & BACKGROUND:

An application (Z-4005-22) for a proposed change in zoning for the property located at 1109-1117 Jefferson Ave, 137 N 11<sup>th</sup> Street and 122-132 N 12<sup>th</sup> Street, in Toledo, Ohio, was submitted to the Toledo City Plan Commission for its review and recommendation.

On June 9, 2022, the Toledo City Plan Commission recommended approval of the request for a zone change from "IL" Limited Industrial to "CD" Downtown Commercial for the property located at 1109-1117 Jefferson Ave, 137 N 11<sup>th</sup> Street and 122-132 N 12<sup>th</sup> Street, Toledo, Ohio.

On July 13, 2022, the Toledo City Council sent with a recommendation of approval of the request for a zone change from "IL" Limited Industrial to "CD" Downtown Commercial for the property located at 1109-1117 Jefferson Ave, 137 N 11<sup>th</sup> Street and 122-132 N 12<sup>th</sup> Street, Toledo, Ohio.

NOW, THEREFORE, Be it ordained by the Council of the City of Toledo:

SECTION 1. That the zoning maps attached to Part 11, Planning and Zoning, Toledo Municipal Code, are hereby authorized to be revised by changing the zone districts of that part of the City of Toledo more fully described as follows:

The reason for the emergency lies in the fact that same is necessary for the immediate preservation of the public peace, health, safety and property, and for the further reason that the Ordinance must be immediately effective in order to provide for the orderly regulation and use of the property and to protect the land value in the area.
