**Authorizing the expenditure of \$175,000 from the Capital Improvement Fund for the upgrade of signal equipment throughout the city; authorizing the Mayor to accept bids and award contracts; and declaring an emergency.**

**SUMMARY & BACKGROUND:**

This Ordinance authorizes expending \$175,000 from the approved 2021 Capital Improvement Plan (CIP) budget for signal equipment upgrades.

The fiscal impact of this Ordinance is as follows:

NOW, THEREFORE, Be it ordained by the Council of the City of Toledo:

SECTION 1. That the sum of \$175,000 is authorized for expenditure from the Capital Improvement Fund, Account Code 5040-22500- 8CP2108SIGNAL, for upgrades of signal equipment.

SECTION 2. That the mayor is authorized to accept bids and award contracts for the purpose identified in Section 1.

SECTION 3. That the Director of Finance is authorized to draw warrant or warrants against the above account code in payment of the above authorized obligations in an amount not to exceed \$175,000 upon presentation of the proper voucher or vouchers.

SECTION 4. That this Ordinance is declared to be an emergency measure and shall take effect and be in force from and after its passage. The reason for the emergency lies in the fact that the same is necessary for the immediate preservation of the public peace, health, safety and property, and for further reason that the Ordinance must be immediately effective in order to meet federal mandated standards for pedestrian signals.
