**Authorizing the mayor to accept and deposit a grant from The Hospital Council of Northwest Ohio in an amount not to exceed \$13,435 into the Operation Grants Fund to assist Toledo Fire & Rescue with the purchase of EMS Equipment for Disaster Preparedness; authorizing the appropriation and expenditure of the grant proceeds; and declaring an emergency.**

**SUMMARY & BACKGROUND:**

The Hospital Council of Northwest Ohio (HCNO) is pleased to announce that The Toledo Fire and Rescue Department has been awarded the Northwest Ohio Regional Health Care System Coordination for Disaster Preparedness Mini- Grant. This \$13,435 grant is awarded to assist with the purchase of EMS Equipment for Disaster Preparedness. The total cost for the equipment shall not exceed \$13,435.

The fiscal impact of this ordinance is as follows:

NOW, THEREFORE, Be it ordained by the Council of the City of Toledo:

SECTION 1. That the mayor is authorized to accept a grant from the Hospital Council of Northwest Ohio (HCNO) in an amount not to exceed \$13,435 for assistance with the purchase of EMS Equipment for Disaster Preparedness.

SECTION 2. That the said grant proceeds shall be deposited into the Operation Grants Fund, Account Code 2016-53000-3G02417STDSTD.

SECTION 3. That an amount not to exceed \$13,435 is appropriated from the unappropriated grant proceeds of the Operation Grants Fund to Account Code 2016-53000-3G02417STDSTD; and the expenditure of same is further authorized for the purpose identified in Section 1.

SECTION 4. That the Director of Finance is authorized to draw his warrant or warrants against the Account Code listed in Sections 2 and 3 in an amount not to exceed \$13,435 in payment of the above obligations upon presentation of the proper voucher or vouchers.

SECTION 5. That this Ordinance is declared to be an emergency measure and shall be in force and effect from and after its passage. The reason for the emergency lies in the fact that it is necessary for the immediate preservation and safety of the citizens of Toledo in the event of a disaster, for timely procurement of EMS equipment, and to comply with grant funding obligations.
