The City of Toledo has been awarded funding and is invited to enter into a grant agreement with the Ohio Environmental Protection Agency (OEPA) for a H2Ohio grant in the amount of \$2,463,591 to be used for the Raw Water Main Design project at the Water Treatment Plant. This ordinance authorizes the acceptance, deposit, appropriation and expenditure of up to \$2,463,591 in grant proceeds from OEPA.
