**Authorizing the Mayor to enter into and execute cooperative agreements between the City of Toledo and Lucas County and to give consent to Lucas County for intersection improvements at Monroe Street and St. Clair Street; authorizing the contribution of \$108,537 for said project; and declaring an emergency**

**SUMMARY & BACKGROUND**

As part of the updates to the Glass City Convention Center, Lucas County moved the entrance to the parking garage from Summit Street to the intersection of Monroe Street and St. Clair Street. The work included new signal poles and crosswalks at St. Clair and Monroe.

Lucas County administered the design and construction of the project with County funds. The City of Toledo will participate in the costs by paying a lump sum amount not to exceed \$108,537 for design changes requested by the City during construction to be paid for with previously approved Matches and Planning Funds.

NOW THEREFORE Be it ordained by the Council of the City of Toledo:

SECTION 1. That the Mayor is authorized to enter into and execute cooperative agreements between the City of Toledo and Lucas County for intersection improvements at Monroe Street and St. Clair Street, upon

terms and conditions acceptable to the Director of Law and the Director of Transportation.

SECTION 2. That the City of Toledo gives consent to and shall cooperate with Lucas County, in connection with the above project as follows:

- 1) The City of Toledo agrees to contribute an amount not to exceed \$108,537 for design changes.
- 2) The County agrees to be the lead agency and to administer the construction phase of this project.

SECTION 3. That this Ordinance is declared to be an emergency measure and shall be in force and effect from and after its passage. The reason for the emergency lies in the fact that this Ordinance is necessary for the immediate preservation of the public peace, health, safety, and property and for the further reason that this Ordinance must be immediately effective in order to permit timely reimbursement to Lucas County for design changes.
