Authorizing the re-appropriation of \$47,405.39 within the Local Fiscal Recovery Fund; authorizing the expenditure of same for support of the Young Artist At Work Program through the Toledo Arts Commission; authorizing the Mayor to enter into necessary agreements for this purpose; and declaring an emergency.

SUMMARY & BACKGROUND:

The city is the recipient of \$180.9 million through the American Rescue Plan Act (ARPA) to be used to address the public health and negative economic impacts of the COVID-19 pandemic. The Toledo Recovery Plan framework (authorized by Ordinance 530-21), which outlines the city's projects that will be funded through ARPA, includes \$6,000,000 for youth and recreational programming. This Ordinance authorizes the re-appropriation and expenditure of \$47,405.39 of previously appropriated funds for support of the Young Arts At Work program administered through the Toledo Arts Commission.

NOW THEREFORE Be it ordained by the Council of the City of Toledo:

SECTION 1. That the disappropriation of \$47,405.39 is authorized from the Local Fiscal Recovery Fund from the following Account Codes:

2021-40100-7YOUTH0163NEI \$28,537.39

2021-40100-7YOUTH0168NEI \$18,868

SECTION 2. That the appropriation of \$47,405.39 is authorized from the Local Fiscal Recovery Fund to Account Code 2021-40100-7YOUTH and the expenditure of same is authorized to support the Young Artist at Work program.

SECTION 3. That the Mayor is authorized to enter into an agreement with the Arts Commission of Greater Toledo for the purpose of administering the Young Artist At Work program, upon such terms and conditions as acceptable to the Director of Parks and Youth Services and the Director of Law.

SECTION 4. That the Finance Director is authorized to draw warrant or warrants against the above Account Codes in payment of the above-authorized obligations in an amount not to exceed \$47,405.39 authorized upon presentation of the proper voucher or vouchers.

SECTION 5. That this Ordinance, being an emergency measure, shall take effect and be in force from and after its passage. The reason for the emergency lies in the fact that the Ordinance is necessary for the immediate preservation of the public peace, health, safety and property and for the further reason that this Ordinance must be immediately effective in order to allow the timely execution of the Arts Commission program.

Vote on emergency clause: yeas 11, nays 0.

Passed: April 10, 2024, as an emergency measure: yeas 11, nays 0.
